Real Estate Investment and Finance

This BOMI International course is required for both the RPA® and FMA® designation programs.

Through this course students will learn to take charge of real estate investments in order to maximize the value of a property. Students will develop knowledge about basic financial concepts as they relate to real estate, including valuation, analysis, taxation, depreciation, and life-cycle costing. Similarly, they will learn to evaluate real estate investments and to develop budgets that estimate net operating income. Students will study the income capitalization approach and cover property taxation costs and strategies to offset these costs. Students will also gain the skills to conduct discounted cash flow analyses and calculate net present value and internal rate of return. This course features exercises that require the basic use of the HP 10bII* financial calculator.
