Contestant Eligibility

There is no limit to the number of times an individual may compete in the Miss Rodeo Idaho Pageant as long as the contestant meets all eligibility requirements.

Each contestant in the Miss Rodeo Idaho Pageant shall on the date of competition:

- a. Must be at least 19 years of age and not 25 years of age or older and will not have attained age 25 as of December 31st of the pageant year, and a female. This and her birth date to be proven by her birth certificate to be presented with her application,
- b. Have obtained a high school diploma or equivalent of high school education,
- c. Not have been, currently be or become engaged, married and/or pregnant,
- d. Be a verifiable resident of the state of Idaho,
- e. Not have been a prior contestant in the Miss Rodeo America pageant,
- f. Not be a state or national title holder of any other pageant in the year of competition.
- g. Have executed all consents and/or waivers of liability presented as conditions to participation,
- h. Have been certified as the representative by the designated local pageant or local sponsor,
- i. Have not been previously disqualified or removed as representative for this or any other title.
- Abide by all rules and regulations as set forth by Miss Rodeo Idaho and Miss Rodeo America Pageants.

Any contestant not meeting the qualifications outlined above may be denied the right to compete in the Miss Rodeo Idaho pageant.
