RESOLVED, by the <u>Board of Trustees</u> of <u>Liberty Township</u>, Trumbull County, Ohio, all members elected thereto concurring, that it is necessary to levy an <u>renewal</u> tax in excess of the ten mill limitation for the benefit of <u>Liberty Township</u>, for the purpose of providing and maintaining fire apparatus, appliances, buildings or sites therefore, or sources of water supply and materials therefore, or the establishment or maintenance of lines of fire alarm telegraph, or the payment of permanent, part-time or volunteer firefighting personnel or fire fighting companies to operate the same, including the payment of fire fighter employers contributions required under R.C. 742.34 or to purchase ambulance equipment, or to provide ambulance, paramedic or other emergency medical services operated by a fire department or fire fighting company, at a rate not exceeding <u>1.5 mills</u> for each one dollar of valuation which amounts to <u>\$0.15</u> for each one hundred dollars of valuation, for a period of five (5) years, commencing tax year 2015 collection year beginning 2016.

BE IT RESOLVED that the Fiscal Officer Certify a copy of this Resolution to the County Auditor for certification of the total tax valuation of Liberty and the dollar amount of Revenue to be generated by the tax;

BE IT RESOLVED upon certification of the County Auditor that the provisions of said tax levy be submitted to the electors of said Liberty Township, in the general election to be held on the 4th day of November, 2014; and

BE IT FURTHER RESOLVED that said tax levy be submitted to the electors under the authority of Ohio Revised Code, Sections 5705.03, 5705.19(I) and 5705.191; and

RESOLVED that the Fiscal Officer of this Board of Trustees of Liberty Township be and he is hereby directed to certify a copy of this Resolution to the Board of Elections, Trumbull County, Ohio, not less than ninety days prior to the election and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Card limit: \$1,000.00 per month; Restrictions on the type of vendors and merchants from who purchases can be made. Specific prohibitions on the types of goods or services that may be purchased such as entertainment, alcoholic beverages, medical drugs, personal services, cash advances, etc. Frequency of use limits: The Township wants to take steps to ensure cardholder do not use the credit card to acquire items that are available through other preferred means.
