*Directions from 281 North Expressway:*

Exit at Donella Northbound or Southbound. Northbound it is one exit past Thousand Oaks/Mecca. or Southbound 281, it is 1 exit past Loop 1604. Proceed West on Donella for 2 long blocks to Mustang Circle - - Turn right up the hill to a stop sign at Rua De Matta. Turn left (West) on Rua De

## **Big Slough (off the Neches River)**

The premier paddle in East Texas is Big Slough, a large area that is flooded in the winter and spring. Located in the Davy Crockett National Forrest, between Alto and Crocket. After hunting season you don't encounter many people. Massive Oaks, Gums, Hickorys (including a few of the remaining Scaley Barks, once common in East TX). The trees are probably 100 to 200 years old. I have seen deer, feral hogs, coons, eagles, gators, and river otters, very rare plants like the Neches River Rose Mallow, all kinds of flowering plants.

It is an outstanding spring float. An eleven mile loop down Hickory Creek, up Big Slough, down the Neches, then back up Hickory Creek. At summer and fall levels it is brutal. Lots of going under, over, and around trees in the

creek. At spring levels it is a moderate loop, requiring some boat control skills and paddling upstream for half the trip. The scenery makes it worth while.

It began as a marked, maintained trail. When the area achieved wilderness status, the Forest Service had to remove the signs that said Big Slough Canoe Trail. When the slough is flooded you can get yourself seriously lost.

This is one of the last remaining wet land areas in East TX. You may spend part of the day lost or fighting your way through; the easy way through changes with the water level; that is what it makes it interesting.

A couple of times, we've put in with sea kayaks at Cavasso and paddled across the bay to backside of Refuge and up Big Bayou. But that's more of a touring boat trip with compass and GPS in hand. But it did give us a chance to paddle personally with gators, something that puts a new spin on staying kayaker side up.

The creek doesn't look like much at the muddy put in, but it opens up into a wide mouth on the bay with nice grass and lots of birds and fish. Outside of the creek mouth, which is pretty big, you can get surprised by the intensity of the wind and waves.

Had to basically ferry the bay one time to get back, when we failed to get interested in the weather report and

taking those waves on our beam was not an option.

But you can have a real good time just gunkholing along the mainland side.

## **USCA Canoe Instructors Certification Course**

Bob Spain, a USCA Certified Instructor/Trainer is offering a United States Canoe Association (USCA) Canoe Instructor Course in January. The course will cover basic instruction to teach a "beginner canoe" course. The course will include 4 hours of classroom instruction followed by 4 hours of on-the-water demonstration. The cost of the course is \$95 which includes an instruction video, instructors polo shirts and membership in USCA, which is required. If you are already a USCA member the cost is \$75. All students will have to pass a CPR /first aid course to receive the canoe certification (you can take the instructors course before you have your CPR certification, but you must pass the CPR course before you can receive your instructor's certification card).

He prefers to schedule the class on Friday and Saturday, because he can get some assistance from other instructors for the Saturday on-the-water portion. However, he may hold it during the week if that is preferred by a majority of the students. The maximum course size to 12 to 14 people, but if two courses are held at the same time, he may combine the classroom portion into one larger class.

Based upon the initial interest, he will finalize the dates

## Proposed Legislation

The controversy over 4 X 4's traversing river beds is familiar to those subscribing to CanoeTX. For those not subscribing, there is little public land in Texas for public use. River beds constitute the single most common example of such land.

4 X 4 enthusiasts have taken to using river beds as trails for club outings and individual trips. Heavy vehicular traffic can damage riverine environments, which has led to calls for restrictions on use.

An issue of importance to paddlers is whether restrictions on 4 X 4's will also affect paddling. Many bills addressing this situation are likely to be introduced in the coming legislative session. One such bill proposed by Robert Puente (D. San Antonio) is House Bill 206.

This poses risks to paddlers. It gives river authorities the power to regulate vehicles. Boats are well within the commonly understood meaning of the word "vehicles." It also gives river authorities the power to regulate for the "public safety." This could easily lead to more river closures such as that experienced in Comal County after the recent floods.

Many more bills are introduced than are passed. There is no reason to believe this particular bill will actually become law, particularly in its present form. Some restrictions are likely, however, and neither is there any reason to believe whatever does become law will be any more solicitous of paddlers' concerns than is this bill.

HB 206's text follows. The emphasis is added.

**A Bill to Be Entitled:** an Act relating to the protection of the natural condition of the beds and banks of state-owned watercourses; providing civil and criminal penalties.

Be it Enacted by the Legislature of the State of Texas:

SECTION 1. Title 11, Natural Resources Code, is amended by adding Chapter 212 to read as follows:

Chapter 212. Protection of Natural Condition of Beds and Banks Of State-owned Watercourses

Sec. 212.001. Power to Adopt and Enforce Rules.

(a) A river authority may adopt and enforce rules to:

(1) **limit or prohibit vehicular access to and use of the beds and banks of the state-owned watercourses** within the authority's boundaries in order to protect the natural condition of the beds and banks against disturbance; and

(2) **prohibit** within the beds and banks of the state-owned watercourses within the authority's boundaries littering, destruction of aquatic habitat, pollution, and **activities endangering the public safety**.

(b) A river authority may not adopt rules under Subsection (a)(1) limiting or prohibiting vehicular access to and use

of the beds and banks of state-owned watercourses by an owner of the adjacent uplands or an agent, employee, representative, or lessee of the owner for reasonable purposes related to usual and customary agricultural operations if the vehicular access and use is limited to those reaches of the watercourse adjacent to the owner's property.

(c) Rules adopted under this section do not affect the use of the beds and banks of state-owned watercourses for:

(1) emergency or rescue operations; or

(2) activities specifically authorized by the state or a political subdivision of the state acting under state law.

Sec. 212.002. Civil Penalty; Injunctive Relief.

(a) A person who violates a rule adopted by a river authority under Section 212.001 is liable to the river authority for a civil penalty of not less than \$50 or more than \$1,000 for each violation. Each day a violation continues is considered a separate violation for purposes of assessing the civil penalty. The river authority may sue to collect the penalty.

(b) A river authority may sue to enjoin a violation or threatened violation of a rule adopted under Section 212.001.

(c) A river authority may sue for injunctive relief and a civil penalty in the same proceeding.

(d) A suit under this section must be brought in a district court in the county in which the violation occurred or is threatened.

Sec. 212.003. Criminal Penalty.

(a) A person commits an offense if the person violates a rule adopted under Section 212.001.

(b) An offense under this section is a Class B misdemeanor.

SECTION 2. This Act takes effect September 1, 2003.
