A Wonderful Final Chapter

I've had the opportunity to attend the Lighting the Path Breakfast as a guest in years past but never would I have imagined that I would be speaking about my own experience with The Chaplaincy. Having said that, I'm honored to share a bit of my story and how the Chaplaincy has helped our family.

Two years ago, our son Matthew, who was 9 at the time, was diagnosed with a terminal form of brain cancer. The neurosurgeon who gave us his diagnosis had tears in his eyes as he said "80% of the children with this diagnosis die within 12 months. The other 20% might make it to 18 months."

The 10 months after Matthew's diagnosis passed as uneventfully as they could for our family. After spending seven weeks in Seattle while Matthew completed his course of radiation to his brain, we returned home and got back to living our lives. Matthew returned to 4th grade, played basketball, baseball, skied, swam, rock climbed, roller skated, bowled, traveled, tortured his sister and spent time with his friends.

Matthew's tumor remained stable for 10 wonderful months. However, as his tumor progressed, Matthew began to understand the difficult truth that it would likely take his life. We told Matthew that when he was in

Heaven, it would be like a sleepover. When you go to a sleepover, we don't see each other, but we're still a family. We still love each other and think about each other, we just can't see each other. We told him that's what Heaven would be like. He was going to go to the best sleep over ever. And even though we won't see each other, we'll always be a family.

As we continued to care for Matthew at home, cancer took his abilities one by one. He lost his ability to walk, stand, sit, eat, swallow, speak and communicate with us. He slept nearly all day.

Even in the end of his life, Matthew continued to make us laugh. His right arm became constricted as a result of his tumor growing. Because he had lost his ability to speak, we were communicating by hand squeezes. Steve grabbed Matthew's right hand one day and said "Matthew, squeeze my hand if your head hurts." Steve waited for the squeeze. He repeated himself, "Matthew, squeeze my hand if your head hurts." Then, in slow motion, Matthew

raised his LEFT hand, put it on top of Steve's hand and squeezed. I think if Matthew could have spoken then, he would have said "seriously dad?"

When our hospice team, including our nurse Cleo, walked through the door that first time, I felt an immediate sense of relief. We had an instant rapport with Cleo. It felt like an old friend coming over to visit. She calmly explained the changes that were taking place with Matthew and what we could expect to happen at each step of the way. She not only took care of Matthew, but she took care of us. She always made time to talk with us, hold our hands and was a wonderful shoulder to cry on. I think of Cleo as the angel of calm in our home during those weeks.

It's easy to forget when everyone is so focused on Matthew that our daughter Megan was going through an unimaginable time as well. Our Chaplain Craig and Social Worker Heather were a wonderful resource for Megan during that time. I remember a day that they came over to meet with Megan. They played a game in which you got Skittles candy each time you talked about a particular feeling. It didn't take Megan long to figure out that the more you talk about your feelings, the more candy you got. Needless to say, she really wanted Craig and Heather to come back and talk about feelings.

The day that Matthew died, we knew that his time here was coming to an end. We had talked with Cleo earlier in the day and agreed that unless anything worsened, she'd come by later in the afternoon to check in. Cleo had a feeling that she should come earlier in the day, and she did so unannounced. At that exact time, Matthew's breathing changed and not even five minutes after Cleo arrived Matthew died in our arms. I know in my heart that Matthew waited for our angel of calm to arrive before he took that last breath. When I look back on those last moments, I'm so thankful that Cleo was there. I can remember looking at her during the last minute or so of Matthew's life. She gave me a gentle nod as if to say, "yes, this is it....it's ok, you can do this." I don't think I could have remained as calm and present in that moment for Matthew if she weren't there.

Without the Chaplaincy, we couldn't have given Matthew the quality of life he had in his last weeks. We were able to keep him comfortable—at home, with his family, his sweet dog who never left his side and

surrounded by the things that he loved. We will never be able to adequately thank The Chaplaincy for what they have given our family.

Our relationship with The Chaplaincy didn't end when Matthew died. They continue to support us one year later. Our daughter has attended Cork's Place since Matthew's death. Cork's Place is a children's grief group where kids her age come together, bonded by a significant loss in their lives. It's a place where Megan isn't the only person whose lost someone close to her and other kids around her understand what that's like.

Megan isn't the only one in our family who has benefited from Cork's Place. While the children do their thing, the parents meet upstairs and have an opportunity to talk about how our children are coping with grief. And even though the person sitting next to me may not have lost a child, there are still amazing similarities to our losses that we can support each other through.

I'm forever grateful to The Chaplaincy for the support, caring and love that they've shown our family. Losing Matthew has been the hardest thing I've ever experienced. I also think of it as a sacred honor to have been able to be present for his entire life, from his first breath to his last. There is also a wonderful peace that comes with knowing that we gave him a wonderful final chapter to his journey.
