The Council set Spring Clean-Up Day for Saturday April 30, 2016 from 8:00 a.m. to Noon.

Mayor Diercks offered to schedule Active Shooter Training in the City Council Chambers. Mayor Diercks would like to have all Council Members N.I.M.S. trained. Bremer County is offering training for N.I.M.S.

In Other Business Councilwoman Mary Scharnhorst requested 2 Handicap Parking Signs is placed on East Fayette Street in front of Lifeline Assembly of God. The Council will have to adopt an Ordinance to create the two Handicap Parking Stalls. Mayor Diercks informed the Council that Mike Hayes of 210 Iowa Street had contacted him about a group of mailboxes located across the street from his driveway being in the wrong location and he backed into the mailboxes last weekend. The City Council does not feel the Mike Hayes mailbox issue is a City Related Issue. They Council suggested Mr. Hayes contact the Denver Sunset Home or the Denver Post Office. Mayor Diercks requested the Christmas Carolers across the street from City Hall be taken down. Mayor Diercks reported Tom Wooley plans on installing a 10 foot Weathervane on the roof of his building.

The Council made final adjustments to the revenue and expenditure line items for the FY 2017 City Budget. The Council set the Tax Rate at \$6.96225/\$1,000 of valuation. Water rates will increase by \$1.00/month and garbage rates will increase by \$1.00/month and electric rates may increase up to 3% depending upon the outcome of the Electric Rate Study. Larry Farley will be preparing the FY 2017 City Budget Public Hearing Notice for the next City Council Meeting. The council has scheduled March 7, 2016 at 7:00 p.m. for the FY 2017 City Budget Public Hearing.
