- APPROVED VENDORS ARE EXPECTED TO OBSERVE THE STRICTEST COMPLIANCE WITH STATE AND MUNICIPAL RETAIL SALES CODES AND MUST OBTAIN THE PROPER INSURANCE, LISCENSES AND PERMITS. ALL VENDORS ARE RESPONSIBLE FOR THE COLLECTION AND PAYMENT OF SALES TAX TO THE COLORADO DEPARTMENT OF REVENUE, THE CURRENT RIVER RUN VILLAGE SALES TAX IS 5.775%. VENDORS WILL ALSO BE REQUIRED TO REMIT A .5% SALES ASSESSMENT FOR TOTAL GROSS SALES COLLECTED DURING THE FESTIVAL WEEKEND. THIS PAYMENT IS TO BE SUBMITTED ON THE LAST DAY OF THE FESTIVAL TO THE KEYSTONE NEIGHBOURHOOD COMPANY OFFICE.

REQUIREMENTS & FEES

STANDARD BOOTH FEE: \$250 FOR EACH 10X10 SPACE, IF YOU NEED MORE THAN THIS SPACE YOU WILL BE REQUIRED TO PURCHASE TWO SPACES. VENDORS MUST PROVIDE THEIR OWN TENTS AND WEIGHTS, NO STAKES CAN BE USED TO SECURE YOUR TENT. POST-FESTIVAL SECURITY IS NOT PROVIDED. EACH VENDOR WILL BE ASSIGNED A SPACE BY THE KEYSTONE NEIGHBOURHOOD COMPANY STAFF. WE TAKE INTO CONSIDERATION EACH VENDORS NEEDS AND BASE PLACEMENT ON THAT AS WELL AS THE ORDER THEIR APPLICATION WAS RECEIVED. YOU WILL BE PROVIDED A MAP OF YOUR LOCATION LEADING UP TO THE FESTIVAL. MANAGEMENT RESERVES THE RIGHT TO CHANGE ASSIGNED SPACE AT THEIR DISCRETION.

ELECTRICAL NEEDS: EACH VENDOR WILL RECEIVE ACCESS TO 110 V CIRCUIT FREE OF CHARGE. IF YOU REQUIRE MORE AMPERAGE THAN THAT THERE WILL BE AN EXTRA CHARGE OF \$50. ALL VENDORS MUST SUPPLY THEIR OWN EXTENSION CORDS & POWER STRIPS.

VENDORS WILL ALSO BE REQUIRED TO REMIT A .5% SALES ASSESSMENT FOR TOTAL GROSS SALES COLLECTED DURING THE FESTIVAL WEEKEND. THIS PAYMENT WILL BE DEDUCTED FROM YOUR FINAL CHECK FOR THE WEEKEND’S PROFITS.

SET-UP & TEAR DOWN: SET UP WILL TAKE PLACE ON FRIDAY, JUNE 21ST FROM 3PM-5PM OR SATURDAY, JUNE 22ND FROM 8AM-10AM. VENDORS WILL NOT BE ABLE TO DRIVE IN THE VILLAGE AT ANY OTHER TIME EXCEPT FOR THESE DESIGNATED HOURS. TEAR DOWN WILL OCCUR ON SUNDAY, JUNE 23RD AFTER 6PM. VENDORS WILL NOT BE ABLE TO DRIVE INTO THE VILLAGE UNTIL 6:30PM BUT MAY HANDCART OUT THEIR ITEMS BEFORE THAT.
