### RICHARDSON COUNTY BOARD OF COMMISSIONERS

### **OCTOBER 20, 2015**

### CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Sickel at 9:00 a.m. on Tuesday, October 20, 2015. Roll call was answered by Standerford, Davidson and Sickel. The Invocation was given by Chairman Sickel and the Pledge of Allegiance was led by Vice-Chairman Davidson. Chairman Sickel announced that the open meeting laws have been posted at the entrance to the meeting room.

Motion was made by Davidson to approve the minutes of the October 13, 2015, meeting as read. Motion seconded by Standerford. ROLL CALL VOTE: Standerford-aye, Davidson-aye, Sickel-aye. Motion carried.

### **ROAD & BRIDGE DEPARTMENT**

Scott Huppert, Highway Superintendent updated the Board on the routine maintenance being done on county roads and bridges this week. He reported that the bridge crew is working on a bridge north of Shubert and doing bridge inspections. The Board also authorized the Highway Superintendent to advertise for trailer bids to be opened on Tuesday, November 3, 2015 at 11:30 a.m.

A notice was received from the Village of Verdon regarding a nuisance violation of weeds/grasses over 12 inches tall at the County Shop located in Verdon. Mr. Huppert informed the Board that the grounds have been mowed and procedures have now been put into place to mow the extended area around the shop which has been determined to be the County's responsibility.

A petition to vacate or abandon a county road between S27 & S28, T1, R18 was received that had been signed by 10 or more electors residing within ten miles of the road. Motion was made by Sickel to adopt Resolution 2015-2016-21 to instruct the Highway Superintendent to do a study on. Motion seconded by Standerford. ROLL CALL VOTE: Standerford-aye, Davidson-aye, Sickel-aye. Motion carried. (Resolution Book 22, Page 73)

Mr. Huppert updated the Board on the damages from the June 8, 2015 storm that have been turned into FEMA. FEMA has agreed to provide funding to replace a culvert south of Shubert, FEMA site #72, in which this project will need to be let out for bids. Motion was made by Sickel to authorize the Highway Superintendent to advertise for sealed bids for the FEMA culvert project south of Shubert located on 647 Avenue between 716 and 717 Road, to be received and opened at 11:00 a.m. on Tuesday, November 10, 2015. Motion seconded by Standerford. ROLL CALL VOTE: Stnaderford-aye, Davidson-aye, Sickel-aye. Motion carried.

### **SHERIFF, DON POUNDS**

Sheriff, Don Pounds requested approval from the Board for the dismissal of an employee in the Jail. Motion was made by Sickel to approve the request from the Sheriff for the dismissal of an employee of the Jail,
