HOW TO HOLD A "DANCE AMERICA" DANCE

- 1) Get Club/Association or Council/Federation Support / Sponsorship
- 2) Identify a Dance Location

Several clubs could join together to sponsor the dance and help with rental and refreshments.

3) Contact Callers/Cuers

Ask if they would be willing to help by donating their time and talent to this "National" benefit dance.

4) Make a flyer

5) Prepare News Release

Send to media and local publications. Show this as a "National" day of dance. See sample on website.

6) Contact local TV stations

Include date, location, time of dance and a Press Release. (Might include information about sponsoring group)

7) Make a display board - (optional)

This would be used to help promote and advertise this "National Event"

8) Download and print ARTS material available on website:

Ask ARTS articles

9) Record keeping
