## Family of the Month June 2011

This month — as is our tradition — we salute our immediate Past Grand Knight, SK Byron (Bud) Powers, and his wife, Paula, as Family of the Month.

Bud was born in Salem, New Jersey. His mother was a school teacher and his father worked for DuPont; he also served as a Methodist Lay Minister. Bud attended the US Naval Academy in Annapolis, MD, graduating in 1960 and beginning a career in naval aviation that spanned 30 years, retiring with the rank of Captain. It also was at Annapolis where Bud converted to Roman Catholicism and where he met his wife of 50+ years, Paula, a native of Dallas, Texas. A flight attendant with Braniff Airlines at the time, Paula met Bud on a blind date at a pep rally before a Navy-Army game. After the Navy, Bud went on to work for 13 years with BDM/TRM, retiring as Director of Information Technology.

Bud joined the Knights of Columbus in February 2007. Later that year, he completed his 2nd Degree in June and his 3rd Degree in September. He became a member of the 4th Degree in May 2008. Prior to his election as Grand Knight, Bud served as Chancellor (2008-2009) — with ancillary responsibility for Vocations, KCIC and KOVAR — and Deputy Grand Knight (2009-2010). He also has served as Chairman of the Good Shepherd Roundtable and has worked both the Snack Bar and BINGO Operations — where he currently is a manager.

Under Bud's leadership as Grand Knight, the

Mount Vernon Council hosted a series of traditional events and activities to include the biannual Polish Night; the Annual St. Patrick's Day Dinner & Dance; the Annual March for Life; and, the Annual Statewide KOVAR Campaign. Two new — and hopefully recurring — events highlighted Bud's tenure: *The World Day of Prayer for Peace* — which commemorated the tragedy of 9-11 — and *A Salute to America* — which honored our military veterans. However, the program which Bud was most instrumental in "making happen" this past fraternal year was the Virginia State Council *Virgin Pilgrim Rosary Program*. Bud set a goal of 19,800 rosaries to be prayed by our Council during the year. By year's end, our Council had prayed more than 20,000 rosaries — exceeding our original goal and resulting in our Council being named a Marian Council at the annual state convention in April.

A good portion of that effort rested with Paula, who hosted a monthly rosary at the Powers' home for the ladies of the Council. For her part, Paula has worked tirelessly all year long coordinating the work of our ladies — be it decorating the hall for various events like Polish Night and St. Patrick's Day; helping run the Children's Halloween and Christmas Parties; or raising the awareness of PRO-LIFE issues by hosting a luncheon for AAA Women for Choice & MaRih House. Paula also found time to work BINGO every other Friday. After the Powers' sixth child was born (see below), Paula went back to college at night, earned an Associate Degree in Nursing and became a Registered Nurse, working in hospitals for seven years. After she and Bud moved to northern Virginia, she obtained her real estate license, joined Long & Foster Realtors, and currently sells real estate with their daughter, Sheryl, as the *Powers Team Realtors*.

In addition to Sheryl, Bud and Paula have four sons --- Wayne, Stephen, Greg and Mike — and one other daughter — Michelle — and 22 grandchildren. Three sons followed their dad's footsteps and became Navy pilots. Two now fly for American Airlines. Stephen is a member of Council # 10947, while sons-in-law Patrick Sweeney and Dave Vermont are members of Councils # 4522 and #5998, respectively.

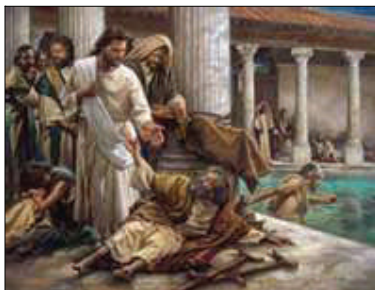

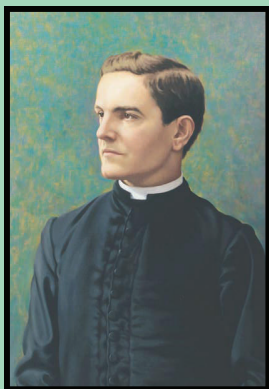

## Supreme Court Rejects Latest Challenge to "Under God" in Pledge of Allegiance

***Knights of Columbus waged successful defense on East and West Coast cases***



The United States Supreme Court has refused to hear an appeal of a lawsuit challenging the constitutionality of the Pledge of Allegiance, thus ending a seven year battle involving two separate cases, one originating in California and the other in New Hampshire. The Knights of Columbus, represented by the Becket Fund for Religious Liberty, played a key role in defending the Pledge as a "defendant intervenor" in both cases.

"The Knights of Columbus is proud to have played a major role in successfully defending the constitutionality of the words 'under God' in the Pledge of Allegiance," Supreme Knight Carl A. Anderson said. "We were instrumental in persuading Congress to add those words to the Pledge in 1954, and they express a fundamental belief that we have held as a nation since our founding, that we 'are endowed by our creator with certain unalienable rights.' The notion that this somehow violates the First Amendment has now been soundly rejected by both the First and Ninth Circuit Courts of Appeal, and the Supreme Court has now allowed both decisions to stand. It is a victory for common sense."

The Ninth Circuit upheld the constitutionality of the Pledge in March 2010 and the Supreme Court refused to hear an appeal of the California case in March 2011. The First Circuit upheld the constitutionality of the Pledge in November 2010 and the Supreme Court denied certiorari in that case yesterday, June 13, 2011.

## **From the Notes of Our Lecturer**

One of college football's most successful head coaches of the past decade was Jim Tressel of Ohio State University. Compiling an overall record of 241–79–2, and a bowl record of 6-4, his career came to the forefront when he coached his team to its first National Championship in 34 years, defeating the heavily-favored University of Miami Hurricanes 31-24 in double overtime in the 2003 Fiesta Bowl. But, his record was seemingly built upon a 'house of cards' as NCAA violations concerning the football program surfaced. On Monday, May 30, 2011, Jim Tressel resigned as head football coach.

What you may not know is that Tressel authored two books about faith and integrity. His book *Life Promises for Success: Promises from God on Achieving Your Best*, published just over three months ago, contains this product description on Amazon's website:

*"Everyone wants to succeed—at work, at home, in relationships, and in life. But sometimes the road to success can be difficult, and even the most seasoned leaders can find themselves in need of some motivation. In Life Promises for Success, Jim Tressel shares a collection of inspiring readings and Bible promises designed to encourage those seeking to succeed in every area of life. Filled with easily applicable Bible verses, motivational quotes, and engaging and inspiring readings, Life Promises for Success is the perfect daily reader for anyone looking to reach their highest goals, achieve greatness, and inspire others to do the same."*

And on the back cover of the book, Tressel writes:

*"If you're struggling with your place in the world, if things have become difficult and you feel like giving up, this little book will encourage you, lift you up when you're wrestling with life, push you forward, and motivate you to be a better person—and a more vital part of whatever team you serve."*

My point in singling out Mr. Tressel is not to pass judgment, but to highlight the importance of integrity. My father, a man I greatly admire, remarked in a recent e-mail about the Tressel brouhaha:

*"(I) see where the Ohio State coach resigned over improprieties. Sometimes folks think they have become bigger than the institution. Something about integrity which fails to remain at the forefront of important people's actions."*

As a career Marine in service to his country for almost 30 years, my father stressed the importance of integrity to his family. He often referenced a quote from Mark Twain that sticks with me to this day, "If you tell the truth you don't have to remember anything." To this day, I remain convinced that the success of my Dad's four children can be boiled down to his emphasis on integrity.

Like my father, I too entered the Armed Forces, but my path took me down the Army's road as a Signal Corps officer. Regardless of which branch of service, however, integrity is one of the cornerstones of leadership. On both the Army's officer and non-commissioned officer's evaluation report, integrity is listed under Army values, along with a description that reads, "Possesses high personal moral standards; honest in word and deed" and then followed by two blocks, one labeled 'yes' and the other labeled 'no'. Anyone who gets the 'no' block checked will not get promoted to the next rank, never. The Army, like the other services, places such a premium on integrity because it cannot afford to do so otherwise. Fighting in harm's way, a soldier must be able to trust his buddy without reservation. Any compromise on integrity is detrimental to the unit's cohesion and its survival.

For all his faults, and the good Lord knows we all have plenty of them, my father never compromised his integrity. Best-selling author H. Jackson Brown, Jr. wrote, *Live so that when your children think of fairness and integrity, they think of you.* As I look back, what a wonderful lesson and example my father and mother have given to me.

As men of the Catholic faith, may we realize the importance of integrity, this beautiful gift God gave us when He wiped away original sin during our baptism. Let us be examples for others through our thoughts and actions. As stated in Philippians Chapter 4, verse 8:

*Finally, brothers, whatever is true, whatever is noble, whatever is right, whatever is pure, whatever is lovely, whatever is admirable—if anything is excellent or praiseworthy—think about such things.*

And, should we ever fall short and lose our way, may we have the courage and strength to ask for forgiveness. R.D. Laing, a Scottish psychiatrist who "ran counter to the psychiatric orthodoxy of the day by taking the expressed feelings of the individual patient or client as valid descriptions of lived experience rather than simply as symptoms of some separate or underlying disorder" said, "The truth brings with it a great measure of absolution, always." Through the sacrament of penance, may we allow the truth to enter our hearts, for we know that "with God all things are possible."

Praised be Jesus Christ now and forever. Amen.

## **PRO-LIFE Report - July 2011**

One often hears from pro-choicers that no one advocates abortion. As is often the case with much of what one reads or hears these days, this is simply not true. While doing research at the Diocese of Portland (Me.) Library a few years back, I remember seeing in the archives a newsletter from a group advocating abortion back in 1971 saying that if some children were not aborted, they would become a burden on Maine's taxpayers. The article was written by a prominent Maine Republican, David Huber. I remembered the name David Huber and his wife Sherry Huber who in 1971 were advocating the legalization of abortion. They were unsuccessful until Roe v. Wade struck down Maine's abortion law. Sherry Huber is still alive and whenever a Republican candidate wants to try to reduce abortions in the state, she comes out with both barrels blazing writing in 2006, for instance, that: "The party -- my party -- has a proud history of defending individual rights, from fighting to end slavery to working to secure equal protection and voting rights for African-Americans; from leading the way in achieving women's suffrage to helping create a federal family planning system. This once-proud tradition is in jeopardy in this year's gubernatorial race. In a June 6 primary debate, Chandler Woodcock made clear his intention to eliminate safeguards for women's reproductive health and safety."

There are literally millions of the "bread and butter" abortion advocates in this country who proudly advocate abortion just in case the baby might incur care in the future to be paid for by taxpayers. I remember standing in Falls Church at a PRO-LIFE vigil out an abortion clinic and having a male drive by in his car and shouting "Who's going to support the kid." There are millions just like him.

Another category of abortion enthusiast is the environmentalist. Less than a year ago, James Lee took three people hostage at the headquarters of the Discovery Station in Silver Spring, Maryland. He was shot dead before he could harm them. This incident did not get much

play in the news, even our local news. Why? Well he left a manifesto behind that was politically incorrect: "Focus must be given on how people can live WITHOUT giving birth to more filthy human children since those new additions continue pollution and are pollution. ....All programs on Discovery Health-TLC must stop encouraging the birth of any more parasitic human infants." His manifesto went on like this for pages and pages. Mr. Lee is not the only environmentalist who sees abortion as good for mother earth.

And finally you have the abortion enthusiasts who strongly advocate the procedure as a positive force in the quest for successful careers for women. I was recently reading a book that quoted the famous journalist Oriana Fallaci about her pregnancy: "the man who fathered my child, my doctor and nurse, my pharmacist, my boss, my best friend, they all said 'get rid of your baby. Abort. Think of your career.'" In her novel, **Letter to a Child Never Born**, written in 1977, the young professional woman protagonist, presumably Fallaci herself, miscarries. Fallaci died of cancer in 2006, childless.

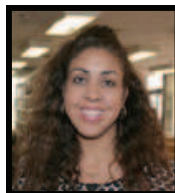
