

February Joint Meeting with Port Manatee Propeller Club

Captain Greg Case, USCG, was the featured speaker for our 2014 joint meeting with the Port Manatee Propeller Club. 65 people gathered at the Sara Bay Country Club for an excellent Italian Buffet Dinner and an interesting presentation of the activities of US Coast Guard Sector St. Petersburg. The Sailor of the Quarter award was presented to the Coast Guard Station Cortez Sailor of the Quarter-Petty Officer 3rd Class Colin Gordon. The station Executive Petty Officer, BM1 Ekahi Lee read the citation and Captain Case presented the award.

Captain Case assumed command of Sector St. Petersburg October 2013. St Pete is one of the Coast Guard's largest commands, with an area of responsibility encompassing over 370 plus nautical

miles of coastline along Florida's west coast. The Sector's five multi-mission small boat stations, four patrol boats, two aids to navigation cutters and one

aids to navigation team have responsibility for four primary operational missions: Search and Rescue; Maritime Homeland Security; Law Enforcement (including drug and alien smuggling, fisheries and other living marine resource regulations, and boating safety); and Waterways Management (including aids to navigation.). Each year St. Petersburg personnel conduct, on average, more than 2600 rescue cases, assisting more than 7000 people and preserving property valued at 39 million dollars. The integrated Coast Guard team that carries out the Group's operational missions is comprised of 340 Regular Military, more than 220 Reserve Military, 4 Civilian, and over 200 Auxiliary personnel.

March Dinner Meeting of Sarasota-Manatee Council

The March Dinner Meeting was held at Sara Bay Country Club on March 20, 2014. Our guest speaker was Rear Admiral Steve Branham USCG (Ret). He was accompanied by his wife, Susan Phillips. Admiral Branham gave a very informative power point presentation of the activities of the Coast Guard 7th District headquartered in Miami and responsible for South Carolina, Georgia, Florida and the Caribbean. While District 7 Commander he commissioned the USCGC Crocodile which we have adopted. Coast Guard District SEVEN's area of responsibility (AOR) covers South Carolina, Georgia, Florida, Puerto Rico, and the Caribbean, encompassing over 1.8 million square miles of ocean. Due to its strategic location the AOR is a "target rich" environment for aircraft and sea-borne vessels, including those involved in illegal human trafficking

and drug smuggling, District SEVEN conducts over 10,000 law enforcement boardings annually. Admiral Branham's presentation was informative and very interesting, and included still- and video-footage of Sector's units conducting interdiction operations

against smuggling operations. Several of those interdictions involved the use of force. The Officer in Charge of Crocodile BMCS Buddy Gilbert and his wife were our guests. We were also pleased to have attending a World War II SPAR, Dorothy Kurtz who is a member of our Council.

John W. Osterweil, philanthropist and council benefactor, was honored with the Navy League's 2013 "Scroll of Honor." Mr. Osterweil, a long-time supporter of our military, was presented the award in recognition of his fund-raising efforts in support of the Earl Fowler Memorial Golf Tournaments that we've conducted over the past eight years, and for his numerous other contributions to our council and its charitable causes.

Vice Adm. Mark Fox assumed responsibilities as Deputy Commander, U.S. Central Command in early September 2013. A native of Abilene, Texas, he was commissioned in June 1978 upon graduation from the U.S. Naval Academy and designated a Naval Aviator in March 1980.

Fox has spent the majority of his operational

career deploying to, and operating in, the U.S. Central Command area of responsibility, having commanded U.S. Naval Central Command/U.S. 5th Fleet/Combined Maritime Forces (2010-2012); Carrier Strike Group 10 aboard USS Harry S. Truman (CVN 75) (2008); Carrier Air Wing Two aboard USS Constellation (CV 64) (2001-2003); and Strike Fighter Squadron 81 aboard USS Enterprise (CVN 65) (1995-1996) in the region. Additionally, he served as Communications Division Chief and spokesman for the Multi-National Force – Iraq (MNF-I) in Baghdad from 2006-07, where he worked extensively with coalition partners.

Other command and executive leadership assignments include service as Deputy Chief of Naval Operations for Operations, Plans, and Strategy (N3/N5) in Washington, D.C.; Commander, Naval Strike and Air Warfare Center in Fallon, Nev.; Deputy Assistant to the President and, Director, White House Military Office (WHMO); responsible for overseeing all military support to the President; commodore of the Strike Fighter Wing, U.S. Pacific Fleet in Lemoore, Calif.; and, service as the first commanding officer of Strike Fighter Squadron 122, the Navy's first FA-18E/F Super Hornet squadron, in Lemoore.

Shore tours include: duty as the Deputy Director of WHMO; service as the Aviation Programs Liaison Officer in the Navy's Office of Legislative Affairs in Washington, D.C.; joint duty

as the maritime plans officer at Supreme Headquarters; Allied Powers Europe (SHAPE) in Casteau, Belgium; Aide and Flag Lieutenant for Commander, Naval Air Forces, U.S. Atlantic Fleet and the Assistant Chief of Naval Operations (Air Warfare - OP-05); a tour as the Light Attack/Strike Fighter junior officer detailer in the Naval Military Personnel Command; and as an A-7E Corsair II instructor pilot in Attack Squadron 174.
