**AFFIDAVIT**

I, Trevor Henry Croll ,  
of PO Box 114, Garfield 3814 (do not mail to 2 Flett Street, Bunyip 3815.

,  
Engineer , make oath and say that:-

1. I am the person making this AFFIDAVIT and I am joint executor of the will of Henry Theodore Croll deceased (Harry), my father, with my mother Lynette Croll.
2. My sisters are Lynette Faye Johnson (Faye), Cheryl Anne Prater (Cheryl) and Leonie Carolyn Dore (Leonie).
3. My three sisters have made application to the Guardianship List to be appointed Administrators and Guardians of my mother's affairs.
4. On the 15<sup>th</sup> June 2003 my father Henry Theodore Croll (Harry) died.
5. On the 5<sup>th</sup> May 2003 I arrived at the family home having been asked to come here by my father as he told me my mother is going to need me.
6. When I arrived I found my father was suffering pain and had been suffering pain for over six months, his cancer that killed him had not yet been diagnosed. My mother and my sister Lynette Faye Johnson (Faye) had been in dispute because my mother had learned that Faye had stolen Harry's best race horse and given it to her boy friend Bruce James. My mother was in a state of distress.
7. I caught Faye hiding my mother's keys and hand bag on her, bullying her, belittling her, and acting in a manner that was aimed at causing my mother great distress.
8. After my father died my mother realised that most of her treasures that she had collected over fifty-five years of marriage were gone. Her coin and money collection valued at \$2,000,000.00 was gone. My mother's medications were missing and Faye initially lied that my mother has thrown them out. Eventually she admitted throwing them out with a justification that they were past their used by date. The dispute between my mother and Faye grew so distressing for both of them that Faye was asked to leave by my mother and her son Glenn Johnson took her away.
9. Faye called my family in Brisbane and tole them lies that I was lazy and making mum wait on me hand and foot. Faye tried to make arguments with me but I refused to argue or fight with her.
10. Cheryl my sister began a campaign of terror on both my mother and I. She told us that Faye had organised a hit man to have me assassinated

and that it would happen so fast I would not even know it had happened. She told that Leonie was going to have me buried in her earth moving business. My mother was told that Faye was coming back to take all the furniture and everything she owned. We were told that Faye was going to become the administrator of my mother's properties and take everything.

11. Faye told my mother that my mother did not deserve any of the properties as she had not worked for it, Harry had earned it. Faye told my mother she belonged in a nursing home.
12. On the 11<sup>th</sup> November 2003 my mother was having stress attacks and heart arrhythmias caused by stress. Heart arrhythmias cause blood clots and these cause stroke. My mother had a massive right side stroke and spent 2.5 months in the Dandenong Hospital. Before my mother was discharged Faye went to her in her hospital bed and had a major argument with her and caused her great distress.
13. On or about the 15<sup>th</sup> January 2004 Faye came to the my mother's home and brought her son Alan Johnson and began removing property claiming it was hers. Alan Johnson (Faye's drug addicted son) with Faye saying hit him, held a 1.3 meter steel pipe (2 inch diameter) at my head threatening to hit me with it. I was able to convince Alan that that was not wise as I would be killed and he would go to jail for a long time.
14. On or about the 1<sup>st</sup> October 2004 I received a telephone call from Leonie Dore and was threatened and abused. The following day George Tribuzi, Leonie's husband, called me and called names, abused and he told me he was coming to Brisbane and was going to bash my head in.
15. On the 26<sup>th</sup> October, in the Dandenong court both Leonie and Faye took top me verbally demanding my mother's address and telephone number. They were asked to leave the courtroom and later did it again outside the court. They were asked to leave the building.
16. On or about the 5<sup>th</sup> September someone who we believe was Faye when my mother and I were not home had entered our house. We found things had been rearranged and some things missing. My mother and I decided it was no longer safe for us to live in my mother's house so we went into hiding in Queensland.
17. The guardianship tribunal is requesting an assessment of my mother and I verily believe my sisters want my mother's address so they can get to her and distress her so that she will not do very well in that assessment.
18. I do believe my life is in danger and I take precautions when I am in Victoria just in case there is someone hiding with a gun going to shoot me when leaving the house. When at home the doors are kept locked

and I have installed security lighting and sensors that turn on a radio to alert me to someone walking around the house at night. I have to come to Bunyip as there are still business matters here that have to be attended to.

19. I verily believe my sisters are aggrieved, as they did not get the inheritance they expected when my father died and have set out to take it from my mother by distressing her into dementia or death. Since I have helped and supported my mother through her time of crises they have set out to scare me away and I verily believe they are capable of killing me or employing someone else to kill me.
20. They have made numerous complaints to the Bunyip Police about me "keeping my mother from them". My mother does not want anything to do with them and has chosen to not give them her telephone number or address and I abide by her request. My sisters have told the tribunal that they will be taking my mother to the supreme court if they do not get their way. Already three doctors support my mother stating that she is competent to run her own affairs.
21. Malicious statements have been made to family and friends about me. I have been called and told I am a proper bastard because of what I am doing. I have simply protected my mother from her nasty aggressive greedy daughters.
22. My mother's assets exceed \$4,000,000.00 and I believe my sisters not only believe they should have her money but are willing to do what it takes to get it.
