Go to **NEXTDOOR.COM/JOIN** and enter your invitation code **ZXJKDJ** and zip code and follow the easy instructions. Takes less than a minute.

"Ah, I get too many emails already!" might be what you're thinking. That's another cool part to how this works. You get one email a day that lists all of the stuff that happened over the last day. You pick and choose the topics that you are interested in. Really easy.
