## Lodging:

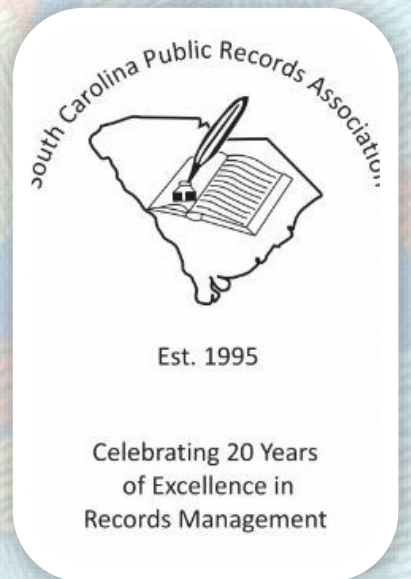
