### I NSTRUCTI ONS TO BIDDERS

- Sealed bids must clearly identify the Bidder's Name and Company in the return address detail and be marked "Lease Agreement for Farm Land East of O'Loane Avenue to the Rear of Avondale Cemetery, City Clerk's Department," addressed to: City of Stratford, City Hall, ATT: Purchasing Department Bl D#: L16 01, 1 Wellington Street, Stratford, Ontario, N5A 2L3 will be received up to: 2:00:00 p.m., Local Time, Wednesday, April 27, 2016 and opened publicly at the same location at: 2:15:00 p.m., Local Time, Wednesday, April 27, 2016
- 2. Each bid shall contain the full name of the party or parties bidding and the signature of the parties bidding shall be in their respective handwriting.
- 3. Bids must be submitted on the attached Bid Form provided.
- 4. The intent of this project is to lease the City-owned Farm Land East of O'Loane Avenue to the Rear of Avondale Cemetery, as per attached, Specifications, Lease Agreement and enclosed diagram, and as directed by Ms. Joan Thomson, City Clerk, (519) 271-0250 ext. 235 or at <a href="mailto:ithomson@stratfordcanada.ca">ithomson@stratfordcanada.ca</a>.
- 5. Lease and use of this parcel of land are to be carried out in accordance with the attached lease agreement.
- 6. The Lessee shall obtain Farm Liability including Farmers Limited Pollution Liability insurance of at least Two Million Dollars (\$2,000,000.00), covering injury to, or destruction of person or property, for which the Lessee may be held liable. The Lessee must obtain Farm Liability including Farmers Limited Pollution Liability insurance on a form of coverage issued by an insuring company acceptable to the City, which names the City as an additional insured. The Lessee shall provide the City, by the 1<sup>st</sup> day of June 2016 and then the 1<sup>st</sup> day of May in each year thereafter during the term hereof, with an insurance certificate showing the required insurance coverage.

- 7. No addendum(s) will be issued within 48 hours prior to bid closing. All addendum(s) become part of the documents and must be acknowledged and/or submitted as instructed with the bid. All addendum(s) will be posted on the City of Stratford website; Bid Opportunities<sup>1</sup>. It is the Bidder's sole responsibility to check the website for addendum(s) prior to submitting their bid. Any bid received without addendum(s) acknowledged and/or submitted as instructed will be rejected.
- 8. No bid will be accepted from any bidder inclusive of its subcontractor(s), which has a claim or instituted a legal proceeding or has threatened a claim or instituted a legal proceeding against The Corporation or against whom the Corporation has a claim or instituted a legal proceeding with respect to any previous contract, without prior approval by Council.
- 9. The highest or any Bid will not necessarily be accepted. The Corporation of the City of Stratford reserves the right to reject any or all bids, or to award the Contract to other than the bidder submitting the highest Bid, as in its opinion may be for the best interest of The Corporation of the City of Stratford.
- 10. Instances where a bid shall be rejected as unacceptable are:

Incomplete bids (all items put to tender are not bid).

Bids are not properly signed and dated.

Bids offered or received after the specified closing time.\*

Bids that contain restrictions placed on the goods or services, by the vendor.

Bids completed in pencil, rather than typed or written in ink.

Bids withdrawn by the vendor or his agent.\*\*

Bids with calculations not completed as per instructions.

Bids completed on forms other than those supplied by The Corporation of the City of Stratford.

Bids submitted without the required documentation attached or completed, bonding, etc.

Bids that do not include samples (if requested).

Bids where the bidder did not attend a mandatory site meeting.

Bids where goods or services do not comply with called for specifications.
