These are just a few things each safety and health professional needs to include, to protect the People, Environment and Property of the facility.

Our March meeting is going to be a special joint meeting with SCISS and held March 22, 2012 at Steven's Steak House starting at noon. This will be a great meeting as we are fortunate to have Maureen Sasson MS, MPH, CIH to discuss the new aerosol transmissible diseases, see you there.
