Deputy Mayor Glen Robinson reported that at a recent board meeting the Board approved the purchase of a new workstation at the Clinic. Discussions were held on the preliminary 2016 budget. The OR was reopened but now Southern Health is looking for an Anesthesiologist. The doctor who formally provided the service is not interested in continuing. Nurse staff is back to full strength at the Altona Health Centre but additional aides are needed at Eastview. A new doctor will be starting a practice at the Altona Clinic in April on 2016.
