## SPF Category

Maximum two teams per division from SPF. Each team comprises of 3 shooters and 1 reserve. Team manager is allowed to participate as one of the 3 shooters or as the reserve.

**(ORNSmen are not allowed to compete in this competition, teams found otherwise will be disqualified)**

## SCDF Category

Maximum two shooters per division from SCDF. Each shooter will be required to attend a compulsory conversion course (Please refer to page 3).

## Invitational Category

Maximum two teams from each Agency/Association. Each team comprises of 3 shooters and 1 reserve. Team manager is allowed to participate as one of the 3 shooters or as the reserve. Untrained shooters will be required to attend a compulsory conversion course (Please refer to page 3).

## Training Sessions - (For Police Divisions/Units)

Participating teams from police divisions/units who wish to conduct training sessions may contact the range directly, subjected to the following conditions:

- 1) Each division/unit is to provide their own Conducting Officers, Safety Officers and all other officials required to conduct a “Live” shooting session.
- 2) Each division/unit is to provide their own weapons, ammunitions, speed loaders and any other necessary equipment during the training session.
- 3) Bookings are strictly on first-come-first-serve basis only and subject to availability.
- 4) External shooting range listed below other than HTA is chargeable.
- 5) Refer to your assigned schedule. You may do an internal exchange of dates however, do notify the range officer.

## General Rules & Regulations

1. All registration form must be submitted to HomeTeamNS on or before 31 July 2015, Friday. Late entries will be not entertained.
2. All participants must be formally trained in .38 Taurus weapon. Participants from the SCDF and Invitational Category must attend the Conversion Course prior to the competition.
3. All SPF and SCDF Category participants **must have a valid HomeTeamNS membership**; those found otherwise will be disqualified.
4. A minimum participation rate of 10 teams for SPF Category, 6 teams for Invitational Category and 5 shooters for SCDF Category must be met for the Category to proceed.
5. All participating teams from Police divisions/units are required to provide weapons, holsters, speed loaders and any other necessary equipment for their individual shooters during the competition.
6. Competition rounds will be provided by the Organiser.
7. NRA targets will be used throughout the entire competition.
8. It is the shooter's responsibility to report punctually to any station that requires his/her presence at a given time. Shooters who report late or missed their shoot will be disqualified. Re-shoot or joining of later details is not allowed.
9. Each shooter is to hand over his/her target cards personally to the scoring room immediately after his/her detail had completed the shoot.
10. Upon handing over the target cards, shooters from the same detail are allowed to remain in the scoring room to view the scoring process.
11. Shooters are not allowed contact with any target cards (including own target cards) after handing over.
12. The scoring process will see the scorer awarding points to each target card in the presence of the shooter. Shooters are required to sign on each of his/her target cards after verification of the points awarded.
13. Shooters are to leave the scoring room upon verifying his/her points stated in clause no.12. No protest will be entertained thereafter.
14. In the event that a shooter wishes to contest the points awarded for a particular shot, a formal protest has to be made immediately within the scoring room to the Chief Classification Officer.
15. A fee of \$50.00 will be levied for each formal protest.
16. Upon receiving the formal protest fee, the Chief Classification Officer will conduct an official review on the particular protest.
17. Any decision taken by the Chief Classification Officer in relation to the protest is final and non-contestable. No appeal will be entertained.
18. The protest fee will be refunded if decision is in favour of the protestor.
19. The Organiser reserves the right to amend the General Rules & Regulations and Competition Format without prior notice.
20. Any decision taken by the Organiser is final.

## COMPETITION FORMAT

The SPF competition comprises of 3 stages. Each participant will be issued with 25 rounds of .38 ammunition. Usage of Laser is optional. Divisions are to provide Speed Loader for their Individual shooters, as required in the competition.

### **Stage 1 (Use of Target A):**

- I. Standing Position behind Barricade at 23-metres
- II. Kneeling Position at 23-metres

For this stage, the shooter will take up position at the 23-metres line behind the barricade. Both feet must be behind the line extending from the firing line to the rear on the exposed or shooting side of barricade. At a given order, he will load 5 rounds of ammunition in his revolver and holster his revolver. He will then load 5 rounds in his ammo-pouch and wait for the next order.

At a given signal, the target will turn and face the shooter for duration of 70 seconds. The shooter will draw his revolver and fire 5 rounds continuously at the target. Upon completion, he will take the kneeling position, unload and reload and continuously fire another 5 rounds at the target. At a given command, he will unload and holster his revolver. Shooter is then required to change his target to "B" and ready for Stage 2.

***\* Unloading of revolver should be at kneeling position. No parts of revolver are allowed to touch the barricade. All shooters MUST keep his hand in contact with the barricade at all times during the live firing. No marks will be given should the shooter failed to keep his hand in contact with the barricade***

### **Scoring System for Stage 1**

Points will be awarded based on the bullets that land on the target. Should the bullet land in between the line, a round gauge will be used to verify and points will be awarded based on the highest point. Maximum score of this stage is **100 points**. There will be no penalty point for every hit outside the target or any rounds that are not fired during the competition.

### **Stage 2 (Use of Target B):**

- I. Standing Position at 15-metres

For this stage, the shooter will take up standing position at the 15-metres line. At a given order, he will load 5 rounds of ammunition in his revolver and holster his revolver. He will then load 5 rounds in his ammo-pouch and wait for the next order.

At a given signal, the target will turn and face the shooter for duration of 30 seconds. The shooter will draw his revolver and fire 5 rounds at the target. Upon completion, he will unload and reload and fire another 5 rounds at the target. At a given command, he will unload and holster his revolver. Shooter is then required to change his target to "C" and ready for Stage 3.

## **Scoring System for Stage 2**

Points will be awarded based on the bullets that land on the target. Should the bullet land in between the line, a round gauge will be used to verify and points will be awarded based on the highest point. Maximum score of this stage is **100 points**. There will be no penalty point for every hit outside the target or any rounds that are not fired during the competition.

## **Stage 3 (Use of Target C):**

### **I. Standing Position at 9-metres**

For this stage, the shooter will take up standing position at the 9-metres line. At a given order, he will load 5 rounds of ammunition in his revolver and holster his revolver.

At a given signal, the target will turn and face the shooter for duration of 8 seconds. The shooter will draw his revolver and engage at the target, firing 5 rounds continuously. Upon completion of the last round, he will unload and take a step back. The order for unload will be given. The shooter will unload and report clear. The detail will then proceed out of the range to clear arms.

## **Scoring System for Stage 3**

Points will be awarded based on the bullets that land on the target. Should the bullet land in between the line, a round gauge will be used to verify and points will be awarded based on the highest point. Maximum score of this stage is **50 points**. There will be no penalty point for every hit outside the target or any rounds that are not fired during the competition.

***\*There will be no grace period or re-shoot should there be any misfired/ faulty rounds. In the event of a tie, the Organiser will take the most number of shots on the highest point to decide the winner.***

***\*Shooters are required to use Target A for Stage 1, Target B for Stage 2 and Target C for Stage 3.***

***\*In the event that additional shots were found on a Target Card, points will be deducted off from the highest point awarded on the same Target Card.***

***\*Participant will be disqualified from the entire competition should he/she violates any safety regulation and/or competition rule.***

***\*Disqualification of any individual will result in the entire disqualification of the Team he/she belongs to.***

## SAFETY RULES & REGULATIONS

Safety precautions are very important as non-compliance may cause the loss of life or serious injury. Below is a list of safety rules, which every competitor **must** obey:-

1. Treat all guns as though they are loaded.
2. Never point a gun anywhere at any time other than at the target area unless you are justified in doing so.
3. Immediately after picking up your guns, “break” open the cylinder and check to see that it is unloaded. After which, check it again.
4. Never give or accept a firearm from anyone unless the cylinder is opened.
5. Be sure that there is no obstruction in the barrel of your gun before loading it.
6. During loading/ unloading/ reloading, the muzzle of your gun must be pointing down at an angle of 45°
7. Never draw your gun from holster or re-holster when the finger is in the trigger guard.
8. Do not draw a revolver or re-holster until you are ready in position at the shooting box/ charge line. In between movement from one shooting box to another, your gun must be pointing 45° to the ground with the finger out of the trigger guard.
9. Never permit the muzzle of your gun touching the ground.
10. Never fire a succeeding shot after any malfunction without first unloading and checking the barrel for obstruction.
11. Never leave the firing line without first unloading your gun.
12. Do not load your gun unless otherwise instructed to do so by the Range Conducting Officer.
13. No person other than the Range/ Competition officials is permitted beyond the Firing Line when live firing is in progress.
14. Never anticipate command – always wait for command.
15. Strictest discipline must be maintained. Carelessness cannot and will not be tolerated throughout the competition.
16. All safety precautions must be strictly enforced and adhered to.
