## Rules for Giving to NDN 501(c)(4)

Contributions to NDN will not be made public through the FEC or the IRS. Contributions to NDN are unlimited and do not affect an individual's aggregate Federal contribution limit. Corporations may contribute unlimited monies to NDN. Contributions or gifts to NDN are not deductible as charitable contributions for federal income tax purposes. NDN may accept contributions from certain Trusts or Foundations depending on their individual policies and restrictions.
