Notes (Individual)

General: As recorded in the **Upton Encyclopedia CD Rom**. "Benjamin [great grandfather of Benjamin Upton in Duval County, Florida] was without any doubt the most successful of the Georgia Uptons. . . he was granted and purchased several thousand acres of Georgia land. He left a large estate, including many slaves." It appears that Benjamin's namesake, his great grandson Benjamin Upton (son of his grandson Asa Upton) was equally successful with several locations in the lumbering business in Duval and Nassau counties in Florida and Charlton County in Georgia almost to the end of his life in 1895.

Birth (abt 1750): How old did a male have to be to petition for land? This would help determine how old Ben was at the time of this petition.

Land Grant (1769): Also from the Upton Encyclopedia, "Benjamin's 1769 grants along the Green Briar were in St. Paul Parish, which became Richmond Co. with the outbreak of the Revolution in 1777, then became Columbia County in 1790. Benjamin was a wealthy land owner owning many slaves and land in several counties."

Notes (Family #1)

Marriage (bef 1788): Obedience was born around 1787 according to the 1850 census. If she was not born out of wedlock they would have had to have married around 1787.

Benjamin Upton and his wife, Judith, both of Warren Co., GA sold to William Bird and Benjamin Augustus Hamp of Lexington, Warren Co., GA for the sum of five shillings sterling a certain tract of land 30 ft. wide, which adjoined the property of William Bird. Bird and Hamp wanted to build a mill on the Ogeechee River. Benjamin and Judith kept their right to fish the rivers for themselves and heirs.
