

YPA Student Parking Contractual Agreement

Parking

For the safety and well-being of students as well as for the purpose of conserving energy, the YPA School Board requests parents to encourage students to ride school buses where available, and students who live within walking distance of school to walk to school. Where private transportation is necessary, the parents are encouraged to do the driving. Parking on school property is a privilege extended to students in grades 10 who do not owe fees or fines. A fee of \$20.00 is required to park on campus. Cars must have their hang tag displayed on the rear view mirror. Permission to park on school property may be rescinded by the administration for any person who does not observe regulations.

Student parking is located in the <u>Student Union parking spaces</u>. Students should enter the school from Eastview Road. Anyone parked in handicapped parking is subject to school discipline as well as actions taken with law enforcement. Students with debts cannot register for parking. If debt occurs during first semester before receiving a parking pass, driving privileges will be revoked second semester until debt is paid in full.

DRIVING RULES AND REGULATIONS

YORK PREPARATORY ACADEMY Parking Lot Contract

To drive a car on campus the following rules and regulations must be obeyed:

- 1. All drivers must meet the following requirements.
 - Student must present a valid driver's license.
 - Vehicle registration.
 - Proof of Insurance.
 - Class Schedule 2012-2013
 - YPA Student Parking Contractual Agreement Form signed by student and parent/legal guardian.
 - All eligible drivers must have a 2.5 GPA on their 1stSemester report card as of the end of the 1st Semester and maintained each semester thereafter.

- 2. Vehicles must be operated on campus in a safe manner and not exceed a speed of 10 M.P.H.
- 3. Student vehicles must have a valid hang tag and **be properly displayed** on the rear view mirror in order to park on campus.
- 4. All vehicles should be locked and no valuables left inside. YPA assumes no responsibility for a vehicle or its contents.
- 5. Any theft or damage should be reported immediately to the front office.
- 6. The parking lot is off-limits during the school day. All other students must leave the parking area immediately after parking their vehicle, and not return until after school. After school, students must leave school property immediately, unless involved in extra-curricular activities.
- Once a student comes on school grounds, he/she may not leave campus without first reporting to the office to get permission to leave. They must then sign out. (1st Offense: 1 week driving suspension 2nd Offense: 2 week driving suspension 3rd Offense: Driving privileges revoked for the remainder of the school year. This is in addition to possible disciplinary consequences for cutting.)
- 8. Due to the limited space available, students may not park their cars at an angle taking up more than one parking space.
- 9. Students must park in their designated area only.
- 10. No student may park in the Teacher's Parking Lots. This is an automatic fine of \$25 for first offense.
- 11. No students participating in activities may park in faculty parking areas before, during, or after school for any reason. This is an automatic fine of \$25 for first offense.
- 12. No student may park in the Visitor's Parking Area. This is an automatic fine of \$25 for first offense.
- 13. If you park in handicap parking at any time, you are subject to lose your driving privileges for the remainder of the school year. This is an automatic fine of \$25 for first offense.
- 14. No student may register a car and then give or sell his/her parking permit to another student. If this occurs, parking privileges are revoked for both students.
- 15. Board policy prevents Freshmen under the age of 16 from driving/parking on school grounds. (Board Policy)**ENT SERVICES**
- 16. Students must provide the parking office with change of vehicle information as soon as it is known. All vehicles parked on campus must be registered with the parking office. It is the students' responsibility to inform us.Failure to do so will be subject to a fine first offense. Failure to follow this rule may result in any or all of the penalties of #24.
- 17. All students will pay \$20 for their initial parking tag. If a parking tag is not available to be displayed, another parking tag must be purchased by the student.

- 18. If your parking pass is lost or stolen, you may get a temporary for one week only. If it is not recovered, you will need to purchase a replacement.
- 19. Students must submit a written request with their signature and a parent's signature to request a replacement hang tag. No request will be honored without this documentation. The cost of replacing your original hang tag is\$20.00 for the first replacement and will increase in cost after that.
- 20. A temporary parking permit can be obtained in the office for emergency use.
- 21. The student must have previously purchased a parking hang tag. If a student has purchased a parking pass, he/she is allowed three free temporary parking passes. After those three, each will be \$1.00. Students who have not purchased a parking pass will pay \$1.00 per day for a temporary parking pass. NO EXCEPTIONS.
- 22. Students providing false information on the application will have parking privileges revoked for the year.
- 23. Stereo volume must not disrupt the school atmosphere before, during or after school hours as determined by the administration and staff.
- 24. Please read the student handbook that is provided. Driving privileges will be taken for certain offenses.
- All parking transactions must be done between Monday Thursday between 8:00 and 8:20 a.m. or between 3:40 and 4:15p.m and Fridays between 8:00 and 8:20am only. NO EXCEPTIONS.
- 26. Failure to follow parking rules and regulations may result in any or all of the following actions:
 - Warning;

- School Fines (\$5, \$10, \$15, \$20 or \$25);
- Suspension of driving privileges;
- Driving privileges REVOKED;
- Vehicle IMMOBILIZER will be applied. (\$25 fee for removal);
- Vehicle will be towed at owner's expense.
- 27. Parking fines, as any school fine, will put a hold on all school records and/or information including the privilege of purchasing a parking pass.
