U.S. (formed under the District of Columbia Organic Act of 1871), which alliances have turned "The State of Delaware" into a federal enclave and/or federal zone under Corp. U.S.' Buck Act, and have therefore become bound to their agreements with Corp. U.S that limit them from lawfully serving this County, the original jurisdiction Delaware State or its Citizens' needs without a conflict in interest; and,

Whereas, I have specific knowledge that the Governor of The State of Delaware is not the Governor of the Delaware State, which is the original jurisdiction State, and that the original jurisdiction office of Governor of Delaware is currently held by Governor Jeffrey B. Lund; who is running for reelection to that office in this year's election;

Therefore, I, your Affiant, by these presents, do nominate Governor Jeffrey B. Lund as Governor of Delaware, in its original jurisdiction, and do now, hereby, elect and publicly cast my vote for **Governor of Delaware**, by voting for:

# INSTRUCTIONS FOR VOTING BY AFFIDAVIT

Prior to Tuesday, November 3<sup>rd</sup>, 2020

(The underlined [blue](#) text (below) are links to more information.)

- First. Print two copies of the above Affidavit; using the sample affidavit (*see: last page below*) as a guide, fill in the blanks on each affidavit as per the sample's blue example data.
- Second. Go to a notary; and, **in front of the Notary**, following the sample affidavit's red example data, put an "X" over the box to cast your vote and sign each Affidavit.
- Third. Send one of the so executed Affidavits of Elections to the current Governor at the following address:

- Fourth. Make at least two **photocopies** of your Affidavit; one for your own records and send the other to:

The preceding steps are absolutely necessary; however, to secure a perfect paper trail of documents that prove your electoral vote, we hope you will complete the following steps of the electoral process to secure your electoral vote in the public record!

The second notarized copy of the above Affidavit needs to be timely (*to assure delivery on or before: Nov. 8, 2016*) delivered either by hand to: the [Department of Elections](#) [*if delivered by hand, it must be recorded and you must get a copy of that record*], or, mailed, either to said [Department of Elections](#) or to the State Election Commission at:

When mailing, you must use [content notarized mail](#); the evidence created by using the content notarized mail process is your proof of your electoral vote.
