



The Ruth Orton Scholarship, established in 2007 by Ruth Orton, provides a scholarship to a Utah Cottey College graduate who is seeking to complete her B.S. or B.A. degree. She must have high academic achievements, extra-curricular and/or community involvement and established career goals. A woman who has received a scholarship may reapply to receive a scholarship for a second year. Applicants must have been accepted into a college or university of their choice at the time of the scholarship award. The applications of women who satisfy the criteria set forth above will be evaluated on a nondiscriminatory basis without consideration of race, national origin, religious affiliation, sexual orientation, or disability. The scholarship amount varies, with a minimum amount of \$2,500. Scholarship amounts will be based on academic excellence, community/college involvement and financial need. Applications are due April 30.

Application Eligibility

ELIGIBLE CANDIDATES:

- 1. A woman who was a Utah resident when she graduated with an Associate Degree from Cottey College is eligible, regardless of her residency when she applies.
- 2. A woman who is living in Utah and is a graduate of Cottey College, regardless of her residency when she graduated from Cottey, is eligible.
- 3. The scholarship is not intended to assist financially beyond a B.S. or B.A. degree.

Checklist for Application Submission

Applications shall be sent to the chairman of Ruth Orton Scholarship by April 30th of the year in which the scholarship is to be awarded. Recipients of the scholarship will be notified upon approval of the P.E.O. Foundation. The following items are required:

□ Application
□ Statement of Income and Expenses
□ Applicant letter stating her educational background, financial need, career goals, and educational objectives specific to achieve these goals.
□ A total of two letters of recommendation, one personal and one from a Cottey College professor or dean on school letterhead.
□ Proof of application to or acceptance at a college or university of choice. Proof of admission is required to receive funds.
□ Certified copy of transcripts from Cottey College.
