## **Open Keyword Search Evaluation Data Agreement**

This data agreement supplements the terms of the NIST Open Keyword Search 2014 Evaluation Registration Form. In the remainder of this document the term User refers to

User agrees, on behalf of User's Research Group, to receive media (CD-ROM, DVD, hard drive, web download, etc.) containing speech and/or text data from the Intelligence Advanced Research Projects Activity (IARPA) (through the National Institute of Standards and Technology (NIST)) named below under "Corpora/Data Received" and to use the material received under this agreement (the "Data") only for purposes of the Open Keyword Search (OpenKWS) evaluation at the geographic site indicated above. User and User's Research Group may include limited excerpts from the Data in articles, reports and other documents describing the results of work performed for the OpenKWS evaluation. User agrees to insert the following statement in any product, report, publication, presentation, and/or other document that references the data: "This product contains or makes use of IARPA data <version id="">" (see the README for the Version ID and for more information)."</version>
<b>User</b> further agrees not to otherwise publish, retransmit, disclose, display, copy, reproduce or redistribute the Data to others outside of <b>User's Research Group</b> .
After the User's participation in the OpenKWS evaluation has ended, <b>User</b> agrees to delete the Data from any computer or media onto which it has been copied and to return all media to NIST, except that <b>User</b> may keep the Data under either of the following conditions (1) there is a follow-on OpenKWS evaluation and <b>User</b> has signed an agreement on behalf of <b>User's Research Group</b> to participate in that evaluation; or (2) <b>User</b> executes on behalf of <b>User's Research Group</b> a subsequent license that covers the Data. The duration of time that the User may keep the Data under either of the two conditions above will depend on the terms of the follow-on agreements.
