Ethics CLE Speaker:

Mark C. Bishop is the Strategic Partnership Coordinator for the Community Relations Division of the Michigan Department of Civil Rights (MDCR). He works out of the Lansing Executive Office of the MDCR. He has held this position since February of 2011. Prior to that, he was a Civil Rights Investigator with the MDCR. Mark is also an attorney, having received his J.D. from Thomas M. Cooley Law School. He regularly provides training to Michigan businesses and residents on diversity, hate crimes, harassment prevention, and social justice.

Topic - Police and Community Relations:

Police-community tensions have risen in recent years amid scandals in police departments. Michigan is not immune to these problems. Attorney Bishop will speak about what Michigan is doing to deal with these types of complaints, how Michigan is working to prevent and avoid situations such as those in Ferguson and Baltimore, and what we can do as community members.

Capitol to open on Saturdays! Beginning in June the Capitol building will reopen to the public on Saturdays after being closed for nearly twenty years. The hour-long guided tours are free and start every half-hour between 10 a.m. and 3 p.m. Meanwhile, crews have begun work on the \$6.4 million exterior restoration project on the Capitol dome with completion set for November.
