1. The Organising Committee reserves its rights, as laid out in the wording of NZEF Articles 629 & 610.
2. Classes 1, 2 & 3 will be run under all applicable FEI Rules and Regulations.
3. Classes 4, 5, 6 & 7 will be run under ENZ rules.
4. Riders and horses in classes 1, 2 & 3 must be registered with the FEI. All Class 1, 2 & 3 horses are required to have either FEI passports or fully completed official NZEF identification papers. (FEI Article 511)
5. Please include Email address for event newsletter and information. Also available at www.eventingcanterbury.co.nz
6. Cheques payable to Eventing Canterbury Inc. Payment can also be made by Direct Credit to **AC No: 03 0855 0371245 00** . Use your name ,the Event name, and date for reference.
7. Late entries and payments will incur the late fee(\$20) if money not in Bank Account two working days after entries close. Un-paid entries will not be put in draw until payment made.
8. **Scratchings** as per Article 629.Request for refund to be made in writing within 7 days of event. For Classes 1, 2& 3 a veterinary certificate must accompany request for refund.
9. **Qualifications(Class 1, 2 & 3 only)**. (FEI 506) Details of qualifying competitions must be included with entries. **Qualification details are required for each horse and rider** (not necessarily as a combination) Late qualifications accepted. If in doubt, contact secretary.
NOTE: Qualifying competitions must have been held in the current and preceding 2 calendar years – FEI 506.
10. All Class 1, 2 & 3 horses are required to be accommodated on the grounds.
11. **ALL FEI and PreNovice Horses** must be presented for the arrival examination.
12. **Back Number Holders** required for all classes
