









# Proposed Changes FCA Bylaws

To be voted on at February Meeting Feb 13-14, 2015

Please note: **RED** signifies the existing wording and **BLUE** signifies the proposed change.

## ARTICLE II – VISION AND MISSION

**Vision Statement:** The Florida Commodores (~~delete ‘~~)Association (~~delete~~ **add**) is dedicated to sharing knowledge, ensuring the future of Florida yachting and preserving our traditions and customs.

## ARTICLE IV

**SECTION 2 – ASSOCIATE MEMBERSHIP** – Membership in the Associate category is limited as follows:

B. The current sitting Commodore, Vice Commodore, (~~delete “and”~~) Rear Commodore (~~delete~~ **add**) and Fleet Captain of Recognized Yacht Clubs.

C. An Associate Member in good standing (~~delete “shall”~~) (~~delete~~ **add “may”**) be nominated by the Commodore and approved by the Executive Committee to serve an annual term as Associate Member at Large of the Executive Committee to represent the interests of the associate membership of the association.

## SECTION 5 – AVAILABILITY OF AN FCA CHAPTER

A Past Commodore of a qualified yacht club without a recognized FCA chapter may, upon invitation from an existing FCA Chapter, join another yacht club’s FCA chapter (without having to join that Yacht Club unless it is a requirement of the yacht club). If such membership produces (~~delete ten (10)~~ **add five (5)**) or more members from any one (1) qualified yacht club in the FCAs area of coverage, these members must form their own FCA chapter

## ARTICLE VIII – MEETINGS

**SECTION 1 – ANNUAL MEMBERSHIP MEETINGS** – (~~delete~~)**Shall preferably be held the second weekend of October.** (~~delete~~ **add**) **Shall be held in October.** The election of Officers, adoption of the budget, appointment of committees, appointment of necessary officers, and determination of the following year’s meeting schedule, and other necessary transactions shall be accomplished at this meeting.

**SECTION 3 – QUORUM** – A quorum for the transaction of business at any membership meeting shall consist of the representatives of a minimum of one-third (1/3) of the member chapters of FCA provided for under these Bylaws. Each Chapter is to be represented at membership meetings only by (~~delete~~) **its President** or a duly qualified representative of the chapter. (Article X – Voting – Section 1 – Voting at FCA Membership Meetings.)

## ARTICLE X – VOTING

**SECTION 1 – VOTING AT FCA MEMBERSHIP MEETINGS** – The FCA recognizes the principal of One-Member-One-Vote. Only Individual General Members have the right to vote. Associate members are non-voting members. Casting of the votes shall be restricted to (~~delete~~) **Presidents of FCA Chapters** or their appointed (~~delete~~ **add**) **the duly qualified representative** who must present the FCA Secretary with a Proxy Authorization signed by their respective Club Chapter President. (~~delete~~) **Club Chapter Presidents** (~~delete~~ **add**) **Duly qualified Club Chapter representatives** shall represent and cast the vote of each (~~delete~~ **add**) **of the chapter members**. Should an individual chapter member be in attendance at a voting meeting, that member shall be permitted to vote his/her desire.
