

# Law Enforcement & <u>Corrections Exams</u>

The Cities of Bismarck, Lincoln, Mandan, and Minot, and Burleigh, Morton and Ward Counties are combining efforts to test applicants for law enforcement patrol and detention officer positions that may be available in the future.

If you have an interest in becoming a Bismarck, Lincoln, Mandan, or Minot Police Officer, a Burleigh, Morton or Ward County Deputy Sheriff or a Detention Officer, the first step in the process is to successfully pass a written Law Enforcement or Corrections/Detention exam.

These entry-level service exams assess ability to learn and apply Law Enforcement or Corrections/Detention information, remember details, use judgment and logic, verbal ability, ability to follow directions, and inductive and deductive reasoning.

To schedule testing, obtain a test application from Job Service N D, or the Human Resource offices at the Cities of Bismarck, or Minot, Burleigh County, Morton County, or <u>www.burleighco.com</u>. A non-refundable <u>\$25.00 (money orders only</u>) test fee must accompany the application and must be received <u>three (3) weeks</u> <u>prior to test date</u>. Please indicate which exam you are applying for. No one will be allowed to test without confirmation of pre-paid application. (Test dates with less than 5 applicants scheduled may be cancelled.)

Test applicants will be allowed to re-schedule their confirmed testing date one time due to inclement weather or an emergency situation. If for some reason the re-scheduled time does not work out the original non-refundable \$25.00 will be forfeited. Applicants may re-apply and pay the non-refundable \$25.00 fee to sit for the test at a later date.
