Instructions to Respondents

- 1. The following are minimum specifications intended to govern Fire Department Uniforms requested. Prospective vendors are to fill the attached Bid Form and submit with their Bid.
- Sealed bids addressed to the City of Weslaco will be received up until <u>March 14, 2011</u>, <u>at 3:00</u> <u>p.m.</u> at the Weslaco City Hall Purchasing Division, 255 S. Kansas, Weslaco, Texas 78596, at which time they will be opened and read aloud.
- 3. Bids will be submitted in a sealed envelope upon the blank forms of the bid package attached hereto, and marked in the upper left hand corner with the name of the bidder and the words "Fire Department Uniforms, Proposal No. 2010-11-06".
- 4. The successful vendor will agree to supply material that meet the specifications outlined in the attached Uniform Specification Sheet. The successful vendor and the City of Weslaco will enter into a one (1) year agreement stipulating terms not inconsistent with any provisions stipulated in your proposal, with the option to extend for an additional year. In the event that any of the conditions or provisions are not met or your service is unsatisfactory, the City of Weslaco following thirty (30) days written notice may terminate the agreement. Proposals will be analyzed on TOTAL dollar value not item per item and what is most advantageous to the City.
- 5. <u>Quantity subject to change</u>. Quantities shown are approximate and based on previous years records. It is specifically understood that these quantities may be increased or decreased without adjustment to the unit price.
- 6. Prices quoted shall prevail for a period of one (1) year starting on the date of the first purchase order. All prices must be F.O.B. Weslaco Fire Dept. 901 N. Airport Dr. Weslaco, Texas 78596, and include all cost of packaging and delivery.
- 7. The vendor agrees to indemnify and save harmless the City, the Purchasing Division, and assistants from all suits and actions of every nature and description brought against for or on account of the use of patented appliances, products or processes, and he/she shall pay all royalties and charges which are legal and equitable. Evidence of such payment or satisfaction shall be submitted upon request of the Purchasing Division, as a necessary requirement in connection with the final estimate for payment in which such patented appliance, products or processes are used.
- 8. Bids <u>MUST</u> give full firm name and address of respondent, and be manually signed. Failure to do so will disqualify your proposal. Person signing bid must show title or <u>AUTHORITY TO</u> <u>BIND HIS/HER FIRM IN A CONTRACT</u>. Firm name and authorized signature must appear on each page that calls for this information.
- 9. Bids <u>CANNOT</u> be altered or amended after opening time. Alterations made before opening time must be initialed by respondent guaranteeing authenticity. No proposal may be withdrawn after opening time without acceptable reason in writing and only after approval by the City of Weslaco.

Instructions to Respondents continued

- 10. Respondent shall carefully examine the Bid forms, requirements/specifications, and instructions to respondent. Should the respondent find discrepancies in, or omissions from proposal forms, specifications, or other documents, or should he/she be in doubt as to their meaning, he/she should at once notify the Purchasing Division (Weslaco City Hall Purchasing Division, at 956-447-2240) and obtain clarification by addendum prior to submitting any proposal.
- 11. The City of Weslaco will execute payment by mail in strict accordance with the State of Texas Pay Law after the Fire Department Uniforms have been received, and found to meet City of Weslaco specifications. No other method of payment will be considered. State sales tax must not be included in proposal. A tax exempt form will be provided upon request.
- 12. To avoid delay in payments and speed-up handling of invoices, all orders shall be delivered completed. It is the City's policy <u>not</u> to work with back orders.
- 13. The City of Weslaco reserves the right to refuse and reject any or all proposals and waive any or all informalities or technicalities and to accept the bid to be the best and most advantageous to the City and hold the bids for a period of forty-five (45) days without taking action. Bids submitted past the aforementioned date and time will not be accepted.
- 14. Specify number of days required to deliver the Fire Department Uniforms after receiving order must be stated in proposal. Failure to do so, will obligate respondent to complete delivery within <u>TWO</u> weeks from order date.
- 15. When delay can be foreseen, vendor shall give prior notice to the City of Weslaco. Vendor must keep the City of Weslaco advised at all times of status of delivery. Default in promised delivery (without acceptable reasons) or failure to meet specifications, authorizes the City of Weslaco to purchase such item elsewhere and charge increase in cost and handling to defaulting <u>vendor</u>.
- 16. Acceptable reasons for delayed delivery are as follows: Acts of God, (floods, tornadoes, hurricanes, etc.), acts of government, (fire, strikes, war). Actions beyond the control of the successful vendor.

17. Samples of Uniforms shall be provided with your proposals.

18. Colors will be negotiated with successful bidder.
