2. Submit an original, plus one redacted copy. Attachments must be included. Identifying information (date of birth, social security number and account numbers) may be redacted from the copies.
3. All applications (original or renewal) must be submitted with the application fee of \$500.00. Checks should be made payable to the Wise County Bail Bond Board.
4. Applications are to be submitted to the Board thru the Bail Bond Board Staff, located in the District Attorney's Office, 101 N. Trinity, Suite 200, Decatur, TX 76234.
5. If you are submitting an application for license renewal, you must file the application **not later than 31st day** before the license expiration date. For further information, see Occupations Code 1704.162. It is the **responsibility of the license holder** to apply for a renewal. If a renewal application is not timely filed and the current license expires, the license holder shall not execute any bail bond until a new license is issued.

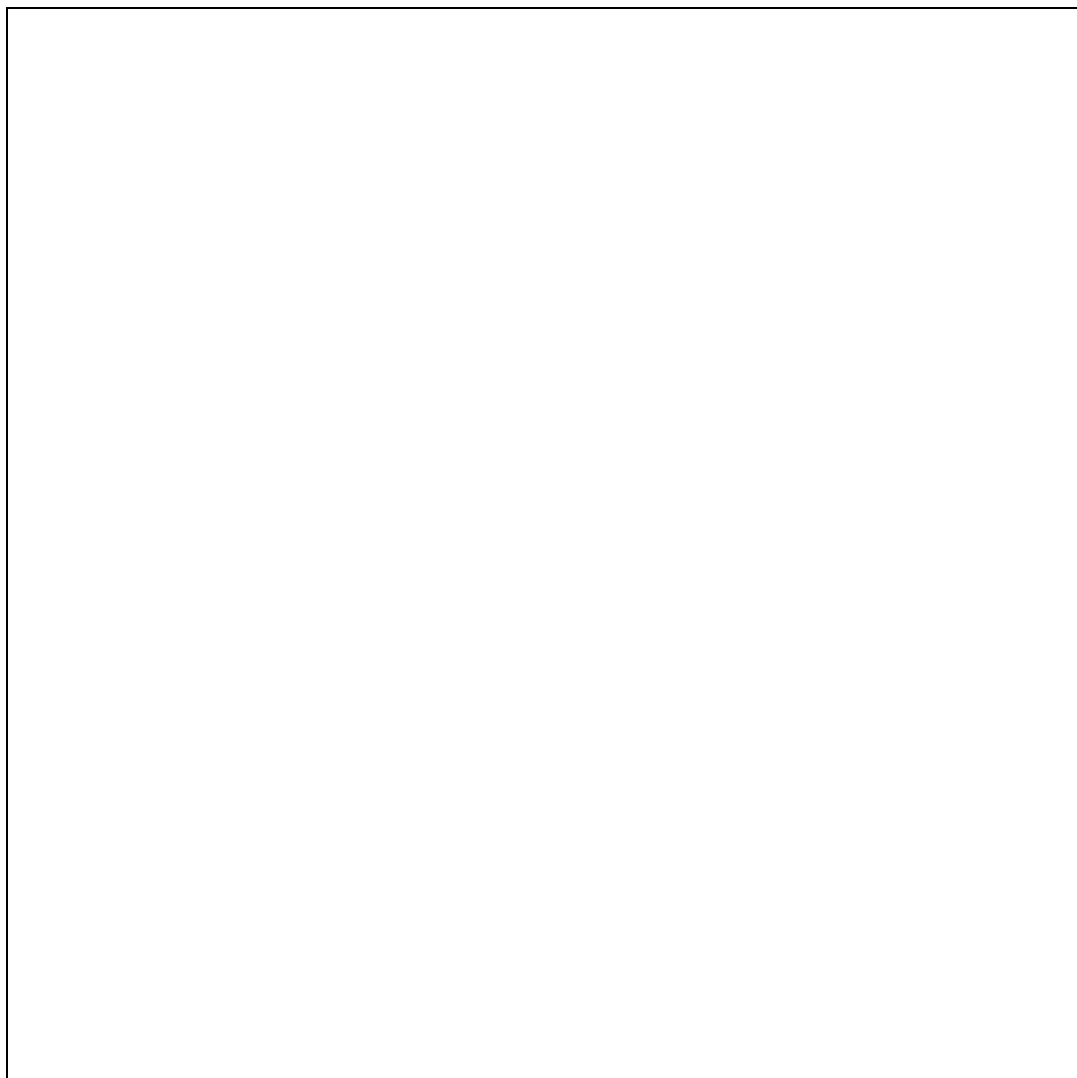
