Instructions for completing the Landlord License Application

Any person renting or leasing real property for gain, either commercial or residential, is required to obtain a general business license under BMC 5.02. Additionally, residential landlords are required to sign a declaration that their properties comply with the standards set forth in the Washington State Landlord Tenant Act (RCW 59.18.060) under BMC 5.06.

Fee Due: The license fee is currently \$75.00 per year, but is prorated monthly throughout the calendar year for new applicants. If you became a landlord during any month other than January, contact our office for the prorated license fee amount. License fees are non-refundable. Licenses are renewed annually.

Mailing Address For License and Renewals: Our office will default the mailing address for licenses and renewals to that of the Property Owner.

<u>Property Owner</u>: (Required for Commercial and/or Residential landlords) For the purpose of this license, "property owner" means the person(s) in whom is vested all or any part of the legal title to the rental property, of all or part of the beneficial ownership and right to present use and enjoyment of the property. Provide the property owner's name, phone number, mailing address, and email address in the space provided. Email is the preferred method of contact used by BPD for the Landlord Notification Program.

Secondary Point of Contact: (Optional) In the space provided, fill in the name and contact information of a secondary point of contact.

<u>Rental Properties</u>: (Required for Commercial and/or Residential landlords) In the space provided, list the address and number of units per address for all of your rental properties within the City limits of Bremerton. For each address check the appropriate box for property type, residential or commercial. If you need more space, attach additional pages.

<u>Signature</u>: (Required for Commercial and/or Residential landlords) All applications must be signed and dated by the property owner or an authorized signer certifying that the information provided is true and correct, to the best of his/her knowledge. Additionally, Residential landlords are required to sign a declaration that each dwelling on all rental properties located in the City of Bremerton are in compliance with the standards set forth in the Washington State Landlord Tenant Act (RCW 59.18.060) under BMC 5.06.
