

The members of Corvette Motorsports Club of Texas invite you to join us at TEXAS WORLD SPEEDWAY for NCCC Time Trial events. TRACK GUYS PERFORMANCE DRIVING EVENTS is hosting a weekend of driver education events and has graciously allowed us to designate several of the events as NCCC sanctioned Time Trial events for those NCCC members who have registered for those events.

Time Trial events are classified as High Speed events by NCCC and participants must have NCCC High Speed certification to participate in the NCCC events.

Time Trial events are relatively new for NCCC members, so this is a brief description: While participating in a continuous lapping session on a defined road course in a controlled situation with multiple cars intermingled on the road course, drivers have their lap times recorded as they improve their skill to find the best line around the track and minimize the lap time while exercising caution in traffic and strictly following event rules for passing and interfacing with other drivers. The quickest lap time of a driver during a session is recorded as the driver's event time for that session. NCCC safety and tech requirements per class are required.

In addition, all the safety, and tech requirements, and rules and regulations of the host organization, TRACK GUYS PERFORMANCE DRIVING EVENTS, are to be strictly followed. THESE ARE THEIR EVENTS AND WILL BE RUN PER THEIR REQUIREMENTS AND DIRECTIONS - <u>NO</u> <u>EXCEPTIONS</u>! Before you can register for these NCCC events, you must register with TRACK GUYS at <u>Track Guys > Events - MotorsportReg.com</u>. They are offering various combinations of track time events on Friday, Saturday, and Sunday March 27<sup>-</sup>29. While you may choose, and are encouraged to register for additional days other than Sunday, you MUST register in either the '<u>Intermediate Driver</u>\_run group, or the '<u>Advanced Driver</u>\_run group for Sunday March 29 to register for these NCCC events. You must also choose the registration option '<u>NCCC Events</u>\_ in order to be eligible for these NCCC events. There will be 4 driving sessions during the day, and during a driving session, each of the Run Groups (Beginner / Novice / Intermediate / Advanced) will have their separate time periods on the track. The NCCC time trial events will be included with the 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> sessions of the day, and the 1<sup>st</sup> session will allow warm-up and practice.

There are 6 NCCC sanctioned events, but a driver will only be able to participate in 3 events, as 3 sanctions are allocated for Intermediate Drivers, and 3 sanctions are allocated for Advanced Drivers. The NCCC event registration payable to the NCCC club CMCT is \$5.00/driver, regardless of the number of events entered (1, 2, or 3).

Please read and become familiar with the Chapter 11-`Time Trials\_ of the NCCC Rule Book <u>https://93075438.domainhost.com/Handbook/NCCCRulebook 2015-2016.html</u>.

In order to have your lap times measured/recorded for these events, you must have a timing transponder mounted on your vehicle. You must furnish your transponder as they are not available at the track. We are trying to locate a vendor to rent transponders, and if successful, this flyer will be subsequently updated.

No host hotel. Numerous hotel options are available in the College Station area.

This is a **NO FRILLS** event weekend, and in order to minimize costs, no awards will be presented.

These NCCCC events are being run in conjunction with Drivers Education events hosted by Track Guys Performance Driving Events. To enter the NCCC events, entrants <u>MUST</u> also register for the Track Guys events on 3/29/2015 and select the registration option for NCCC events. Only entrants registered to participate in the <u>INTERMEDIATE DRIVER</u> run group or the <u>ADVANCED DRIVER</u> run group are eligible to participate in the NCCC events. Track Guys will host events on 3/27/15 through 3/29/15, and options for these additional days are also available at registration. Cost of registration varies by which days/how many days you register for. Track Guys registration is available on-line at <u>Track Guys > Events</u> - <u>MotorsportReg.com</u>. For 2-driver cars: 1 driver must register in <u>Intermediate</u> run group and 1 driver must register in <u>Advanced</u> run group.

A transponder is required on your vehicle in order to record your elapsed time per track lap. Transponders are not available at the track, so you must own, rent, or borrow one in order to compete in the events.

Of the 6 scheduled NCCC events, any NCCC entrant will only participate in 3 NCCC events, according to their Run Group, either Intermediate or Advanced. There will be 4 track sessions on 3/29 and each Run Group will separately participate in each session. The NCCC events will be in conjunction with sessions 2, 3, and 4. Session 1 will allow warm-up / practice time on the track prior to the NCCC events. As NCCC Time Trial events are new and uncommon events, PLEASE READ AND BECOME FAMILIAR WITH CHAPTER 11 OF THE 2015-2016 NCCC RULE BOOK PRIOR TO ARIVING AT THE EVENT. https://93075438.domainhost.com/Handbook/NCCCRulebook\_2015-2016.html
