Please see the AKC Regulations for Agility Trials for current class descriptions. Dogs must be entered only in Regular Classes or Preferred Classes with no crossover between them allowed at the same set of trials.

HEIGHT DIVISIONS

Owners/Agents are responsible for entering the proper height divisions. All height divisions will be offered in both the standard classes and the jumpers with weaves classes.

Regular Exhibitors may choose to enter their dog in a higher height division than required by AKC, but not in a height division lower than the AKC mandated height.

Data Entry and Changes to your Information

******TRIAL REGULATIONS FOR EXHIBITORS*****

RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.

FAX, TELEPHONE AND UNSIGNED ENTRIES cannot be accepted.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules attached to the Official AKC Entry Form are **NOT ACCEPTABLE**.

ENTRIES RECEIVED WITHOUT FEES will not be accepted.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

ACKNOWLEDGEMENT OF ENTRIES will be made as soon as trial closes or limits are reached. Acknowledgment of entries will include confirmation notices.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the match, no refund of entry fees will be made.

ERRORS ON ENTRY BLANKS-Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.

CONSULT FINAL CONFIRMATION FOR TIME OF JUDGING.

WALKTHRUS. No umbrellas allowed during walkthrus.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

DOGS This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), AKC Canine Partners listing number (**if the trial-giving club is offering the option of Canine Partners entries. See front page of the premium for that information**), or approved Foundation Stock Service (FSS) breeds are eligible to participate. All American dogs that have been listed with AKC Canine Partners may participate if the trial-giving club is offering the option of mixed breed entries and provided their listing number has been recorded on the entry form. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

DOGS MAY ARRIVE any time prior to Judging, otherwise, they must be available for measuring before their class begins.

This club agrees to arbitrate claims as set forth on the Official AKC Entry Form for this event.

MOVE-UPS

EMAILED MOVEUPS: When emailing a moveup to us please just give the following information. TRIAL NAME, Owner Name, Dog Call Name, Move up for what days (Saturday, Sunday, etc.), Moving from, Moving to (PLEASE include STD, JWW or FAST) *Remember that you must send a **separate email** with the trial name in the subject line for **each trial moveup** or cancellation.*

MOVEUP DEADLINES: Move-ups prior to a set of trials: Dogs can be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made to the Trial Secretary not later than 6 pm on the Monday preceding the set of trials for trials starting on a Thursday-Sunday. For trials that start on Monday-Wednesday, move-ups preceding the set of trials shall be accepted if received by the Trial Secretary no later than seven (7) days prior to the trial (i.e., for a Tuesday trial move-up requests must be made prior to 6 pm on the previous Tuesday).

Day-to-Day Moveups: the club is allowing day-to-day move-ups for the 2nd and subsequent days of the trial weekend, per Chapter 1, Section 20, the exhibitor is able show up at the trial site and request a move up in writing to the trial secretary not later than the day preceding the event and cannot be conveyed via fax, email, or verbally to the trial secretary.

NOVICE MOVE-UPS

Dogs or Handlers having attained ANY AKC Agility Title (Std, JWW, OR FAST class) **must be moved to the Nov B Classes** (Std, JWW **and** FAST classes). PLEASE LET US KNOW AS SOON AS YOU REALIZE THAT A CHANGE IS NEED. Once we print all the trial paperwork on Tuesday before the trial, it is a much bigger problem to fix. This request must be made in writing at least 30 minutes before the start of the trial. This request must state the reason and justification for the change from Novice A to Novice B. The dog can also be moved up a level (Nov to Open) at the request of the owner subject to the normal move-up criteria.

NOTES FROM TRIAL SECRETARY

1. Please remember to check the No Signature Required box **AND** sign that spot where you authorize them to deliver on any overnight package. My Post Office knows that we do not accept signature-required packages and will not even attempt to deliver them. They just mark them "Refused" and return to sender. So I never even know that you sent that package to me.
2. Remember that the Move-up Deadline for your first day of a weekend trial is ALWAYS **Monday at 6 pm**. Please send those moveups in right away.
3. Please review the section about Moveups as we have added more clarification about moveups before and at the trials.
4. With all the paperwork we handle, mistakes are inevitable. We send out both Preliminary Confirmations and Final Confirmations. **PLEASE read these and double check that all the information is correct.** Having to change Gate boards, scribe sheets and computer records the day of the trial or the week of the trial is very difficult.
5. For Novice Exhibitors – please read the section on the moveup form or under Moveups about when you need to change from Novice A to Novice B and also read the section under classes to determine whether you should enter Novice A or Novice B level classes.

ABOUT EMAILED MOVEUPS & CORRESPONDENCE

When emailing a moveup to us please just give the following information on separate lines.

TRIAL NAME, Owner Name, Dog Call Name
Move up for what days (Saturday, Sunday, etc.)
Moving from (include STD, JWW or FAST)
Moving to (include STD, JWW or FAST)

*Remember that you must send a **separate email** with the trial name in the subject line for **each trial moveup** or cancellation. Each trial is a separate database so I do not know what other trials you are entered in.*

Emails sent to us regarding move-ups, cancellations, etc will be addressed on a priority basis. All correspondence will be processed within one week of receipt; however, those emails that pertain to the current trial will be processed before emails regarding trials that are scheduled for a later date.

We *always* send a reply email to all emailed cancellation requests when they are processed. We *always* send a reply email with a revised confirmation attached to all emailed moveup requests when they are processed.

If a response is NOT received before the above deadlines please email it again and **also** send a backup fax request. Only call me if the emailed and faxed requests do not get a timely reply. I cannot accept moveup request verbally. All moveup requests must be emailed, faxed, or mailed. My Fax number and phone number are always in the premium. ISP SPAM filters can cause non-delivery of emails. Just because you sent an email to cancel or to moveup – that does not mean that I have gotten it. If you do not get a reply - then it means we never got it.

Move-up deadlines are Mondays at 6:00 p.m. before the trial weekend
Cancellation and changes to class (except moveups) deadline is **trial closing date and time (see premium)**. Please remember that Fast Times and the club are not responsible for emails that do not get delivered and therefore will not cancel an entry after the closing date and time or make a moveup after the moveup deadline due to non delivery of an email *request*

TOTAL TURF TRIAL SITE RULES

The club will be charged if anyone arrives at Dream Park prior to noon the day before the event. Anyone who arrives on site prior to this time will be asked to leave the show site.

- **NO DOGS ALLOWED TO "POTTY" IN THE BUILDING.** Failure to observe this rule is subject to a bench hearing and immediate excusal from the trial for the balance of the trial days.
- There will be designated "potty" areas – please be sure you use them.
- **NO DOGS OFF LEASH INSIDE OR OUTSIDE** except in the ring or practice jump areas.
- **No exhibitor chairs, crates, or coolers allowed inside the Main glass enclosed ring area** except where noted below. Handicapped exhibitors will be given signs for their chairs that list the classes/jump heights that they are running in. Chairs must be folded up off to the side during other classes/jump heights.
- Regular personal chairs will be allowed inside the main building but just not INSIDE the enclosed glass area where the actual rings are
- **Because of the tight space in crating area NO PERSONAL CHAIRS in crating area.**
- No x-pens in crating area unless approved by the trial chair.
- **SITE WILL BE CLOSED AND LOCKED within 60 minutes** after the last run each day. No admittance to the site after that time
- **PARKING:** Loading and unloading **ONLY** in front of the main entrance. Do not leave your vehicle unattended in the loading and unloading area. No Parking in this area. All vehicles, trailers, vans, and RV's must be parked in designated areas; NO "DAY PARKING" FOR RVs ALLOWED. NO RVs allowed unless they have reservations to park in the front car parking area. RVs with reservations can only park in the designated RV area. Vehicles not in compliance with parking rules will be towed away at the owner's expense.
- **Limited Handicapped car/van parking** please arrive early to obtain a spot.

Please remember that the hotels is considered an extension of the trial site by AKC and as such can be subject to Event Committee hearings.

Wait List for Withdrawn Entries after Closing

The trial is offering a Wait List to fill openings created by withdrawn entries after the trial's closing. A maximum number of entries will be placed on the wait list based on the entry limits as follows. If trial is one ring/330 runs, maximum will be 25 entries on the waitlist. If the trial is 2 rings/660, the maximum will be 50 dogs on the waitlist. If the trial is 3 ring/990, the maximum will be 75 runs on the waitlist. All entries, including wait listed entries, must be received by the Trial Secretary prior to the trial closing date. Any entries withdrawn that are received by the **WEDNESDAY ONE WEEK BEFORE the trial weekend @ 6pm** will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a waitlisted entry, a refund will be issued for the withdrawn entry. Any waitlisted entry that does not move off the wait list into the trial by **Wednesday @ 6 pm ONE WEEK BEFORE the trial weekend** receive a refund. Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

How do I know if I have a valid jump height card?

If your dog is under the age of two years as of the trial's date: One (1) temporary measurement is required. Once measured, be sure to retain the Agility Measurement Form yellow. If your dog turns two years of age or is older as of the trial's date, your temporary measurement expires on their 2nd birthday and your dog needs to be measured.

If your dog is the age of two years or older as of the trial's date: A minimum of two (2) permanent measurements are required. If both permanent measurements place your dog into the same jump height class, the AKC office will issue you a permanent card. If not, then a third measurement is required to determine the dog's jump height class. Until such time that you have received all required measurements for a permanent jump height card, check the "My dog needs to be measured" box. Upon arrival at the trial, you must check to see if there is a Volunteer Measuring Official and/or an Agility Field Rep. present to perform official measurements. If not, and you possess a yellow copy of the Agility Measurement Form from a previous measurement, then your armband may be picked up during Check-In in lieu of being measured by the judge of record. Once you have received your permanent card from the AKC office, check the "My dog has a **Permanent** Jump Height Card" box on all future entry forms.

Exception to the 2 permanent measurement requirement: If your dog measures over 22 inches at the withers, you have the option of selecting the "Over 22" Request Perm" box at the top left corner of the Agility Measurement Form to receive a permanent jump height card from AKC after a single measurement. If you do so, please also sign below the checkbox. By doing so, you are giving up your right to have a 2nd measurement performed on your dog in the future; however, you are not

giving up your right to have the challenge measurement process performed in the future. Once you have received your permanent card from the AKC office, check the "My dog has a **Permanent** Jump Height Card" box on all future entry forms.

What if my dog measures into a different jump height then what he is entered?

If your dog has been measured by an AKC Field Representative or Volunteer Measuring Official (VMO) and is now eligible to jump in a lower height class, the measurement is effective immediately including any runs (regular or preferred class) which have not yet occurred on the same day that the measurement is recorded. This immediate action does not apply to measurements taken as part of completing the challenge measurement process. Dogs who measure into a higher jump height have always been required to be moved immediately.

May I challenge my dog's jump height card measurement?

Yes, each dog may go through the challenge process once after the age of two (2) years, if requested by the owner. (Any dogs under the age of two (2) years are also eligible for a challenge measurement.)

What is the jump height card challenge process?

The jump height card challenge process replicates the original measurement steps. A minimum of two (2) challenge measurements are required. If both challenge measurements place your dog into the same jump height class, then you will be issued a new permanent card from the AKC office. If the two challenge measurements place the dog in different jump height classes, then a third challenge measurement is required to determine the dog's jump height class.

Until such time that you have received all required challenge measurements, you must continue to compete at the original jump height stated on the permanent jump height card that is in your possession.

It is the sole responsibility of the exhibitor to have their original, official jump height card or temporary jump height form at each trial to present upon request. Additionally, if a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running. *Regulations for Agility Trials, Chapter 2, Section 4.*

NEW Chapter 11 Premier Class

Section 1. Purpose. These optional titling classes are designed to challenge dogs and handlers at an increased speed and skill level above those set for the Master level classes. Handlers/ dogs will need to negotiate courses that require varied approach angles, spacing, and obstacle discriminations to be successful in these classes. These classes are offered as separate titling tracks and are not part of the MACH/ PACH Championships.

Premier may be offered once per day as an additional class or classes. Clubs may, but are not required to offer Premier Standard and Premier Jumpers with Weaves on the same day.

Section 2. Eligibility. Dogs with an AX title are eligible to enter Premier Standard Regular. Dogs with an AX or AXP title are eligible to enter Premier Standard Preferred. Dogs with an AXJ title are eligible to enter Premier Jumpers with Weaves Regular. Dogs with an AXJ or AJP title are eligible to enter Premier Jumpers with Weaves Preferred. Dogs with Regular titles may crossover to the Premier Preferred level as noted above

Section 3. Performance Standards

- Minimum allowable score required to qualify = 100.
- The course must be completed before the dog reaches the Maximum Course Time (MCT).
- Additional Non-Qualifying faults (beyond those listed in Chapter 5, Sections 5 and 6).
 - Any Course Fault

Maximum Course Times (MCT)

Premier Standard

Regular:

- 55 seconds for the 20 and 26 inch Regular jump heights.
- 60 seconds for the 16 and 24 inch Regular jump heights.
- 65 seconds for the 8 and 12 inch Regular jump heights.

Preferred:

- 60 seconds for 16 inch Preferred jump height.
- 65 seconds for 12 and 20 inch Preferred jump heights.
- 70 seconds for 4 and 8 inch Preferred jump heights.

Note: For timing purposes all Premier Standard classes may have timer set for MCT of 70 seconds.

Premier Jumpers With Weaves

Regular:

- 40 seconds for 20 and 26 inch Regular jump heights.
- 45 seconds for the 16 and 24 inch Regular jump heights.
- 48 seconds for the 8 and 12 inch Regular jump heights.

Preferred:

- 45 seconds for 16 inch Preferred jump height.
- 50 seconds for 12 and 20 inch Preferred jump heights.
- 53 seconds for 4 and 8 inch Preferred jump heights.

Note: For timing purposes all Premier Jumpers With Weaves classes may have timer set for MCT of 53 seconds.

Minimum Obstacle Requirements:

- Quantity = 19-21
- Obstacles required, allowed, and not allowed will be the same as the Master level courses as noted in Chapter 6, Section 5 for Standard; and Chapter 7, Section 5 for Jumpers With Weaves, except that both classes will have a maximum of three tunnel passes and Standard will not have a table.
- In both classes the viaduct jumps, as described in Chapter 13, Section 9, can be substituted for the panel jump or a spread jump, as long as the viaduct jump can be set for all heights.

Section 4. Obstacle and Jump Positions. Shall generally follow the requirements set forth in Chapter 4, Section 4, with the following exceptions:

- A Distance of 25 – 30 feet between two obstacles may be approved up to two times on a course.
- Distances of greater than 30 feet between obstacles may be approved to allow for turns between obstacles as necessary.
- There may be one bi-directional tunnel or bar/ single bar jump on the course.

Section 5. Approach Angles. Shall generally follow what is stated in Chapter 4, Section 5, except as detailed in the AKC Agility Judges Guidelines for the Premier Class.

Section 6. Titles. To earn the Premier Agility Dog (PAD), Premier Agility Dog Preferred (PADP), Premier Jumpers Dog (PJD) or Premier Jumpers Dog Preferred (PJDP) titles, a dog must earn 25 qualifying scores with five qualifying scores earned for placing in the top 25% of the dogs that competed in their jump height.

Dogs that are absent or withdrawn will not count toward the number of dogs competing in the jump height. The 25% calculation will be rounded to determine the number of 25% placements in each jump height. In the case of a tie both dogs will receive the top 25% placement. If a class has two or three dogs competing, the 1st place dog will be awarded a top 25% placement qualifying score. If only one dog competes in the jump height, there will be no top 25% placement earned in that jump height.

Lifetime Achievement titles (bronze, silver, gold and century) will be awarded for each additional 25 qualifying scores earned in the Premier class.

INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners** SM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
