- 5. The time allowed to complete the work shall be **Twenty Days** reckoned from the date of work order.
- 6. RAW MATERIAL: All materials and Labour required for the execution of work shall be arranged by the contractor.
- 7. The Contractor will follow all Labour laws.
- 8. The contractor shall maintain all records pertaining to Labour in the required format which shall remain open for inspection by the Engineer in Charge as and when desired by him.
- 9. The contractor shall employ only such workers for the execution of work who are skilled and experienced in their respective trades. The Engineer-in-charge shall be at liberty to object and to ask to remove from work any person employed by the contractor who in the opinion of Engineer-in-charge is not competent or is negligent of his duties. Such a person shall not be re employed again by the contractor without the permission of the Engineer-in-charge.
- 10 The contractor shall follow all safety regulation for the safety of workers/work.
- 11. The contractor shall have to maintain desired progress of works as planned from time to time. In the event of his failure to maintain the required progress of work, the Engineer-in-charge of HPL shall have the right to cancel his contract and or engage a parallel agency for completion of work at the risk and cost of the contractor as deemed fit. In addition to this, HPL will have the right to withhold the machinery etc. of the contractor for use in the work or to release the dues of HPL by sale of such property.
- 12. At any stage during the execution of work if it is felt by HPL that any part or whole of the work is not required to be executed, intimation to this effect shall be given to the contractor and he shall not carry out the said work, the contractor shall not claim any compensation on this account.

- 13. All tools and plants, machinery and fuel etc. required for the execution of work will be arranged by the contractor at his own cost. Nothing extra would be payable for transport, octroi, entry tax, local tax etc.
- 14. The contractor shall not sublet any portion of the work without prior written permission of the Competent Authority.
- 15. **1%** water charges will be deducted from contractor's running bills if it is provided by HPL.
- 16. Work shall be executed by the contractor as per the latest CPWD Specification with up to date amendments and instructions issued by the Engineer-in-charge.
- 17. **5% security deposit** shall be retained from the contractor bills shall be refunded after **3 months** of successful completion of the work.
