

# 2014-15 CHEER TEAM CONTRACT



PARENT INITIAL

Monthly payments are due by the first day of the month. Multiple monthly payments or one annual payment are also gladly accepted. Late fees will be assessed for those fees not paid by the due date. Monthly payments must be maintained in order for a team member to participate in meets. No refunds will be given.

Monthly payments include tuition and competitions, respectively.

I understand that more than two unexcused absences may result in forfeiture of team eligibility. I will inform my coach prior to any absences. I realize it is my responsibility to get drop off my child early and pick up on time.

I realize that participation in this team means attending all the minimum required practice times and that participation in recreational or school activities/ sports does not excuse me from my obligation.

Youth on our team benefit from scholarships as do youth who attend our programs and use the facility. This year we'll host the Applebee's flapjack breakfast on April 11. As part of the team, we commit to supporting this event.

Athletes must attend at least all scheduled competitions. Team competition schedule is provided in advance for your review and commitment. It is also posted on team snap. Please plan accordingly.

Senior team will attend the Myrtle Beach competition in order to qualify for Summit (Worlds competition for levels 1 to 4). I will plan accordingly for my athlete's participation in this event should we make the bid.

Uniform, competition fees, YMCA membership, USASF membership, team parties, special events and travel costs are the obligation of the team member's family. We understand that memberships are not optional and agree to keep them current. Uniform, competition fees, choreography fees, YMCA membership, USASF membership fees are required by **11/1/14**.
