Durango Area Youth Hockey Association MITES TOURNEY 2010 Tournament Entry Guidelines

Note: Protective equipment required in accordance with USA Hockey guidelines

RULE 1 – ENTRY FEE AND APPLICATION FORM

- (a) Applications will be made only on the application form supplied for this specific purpose.
- (b) Each entry application must be accompanied by an entry fee \$295 made payable to DAYHA
- (c) There will be four teams of the Mites level.
- (d) All applications, forms and correspondence must be directed to : Karen Rowan 970-375-1824 or zackrowan@aol.com
- (e) All entries will be refunded if the application is not accepted following the final selections
- (f) If a selected team is unable to attend the tournament, it must immediately notify the Tournament Director by phone prior to the application deadline for a full refund of moneys. If not done within this time frame, the tournament reserves the right to hold and keep all moneys by such team.
- (g) There will be no admission fee for spectators.

RULE 2 – TEAM ROSTER AND PLAYER REGISTRATION

- (a) All players listed on the player roster form (USA Hockey form T-1) must be registered with USA Hockey for the 2009 2010 seasons.
- (b) Tournament officials will check the credentials of each player and each team participating in the tournament. The following credentials will be presented for review to the tournament officials:
 - USA Hockey form T-1 (Team Roster)

The USA Hockey T-1 form must be completed for the 2009-2010 season and bear the signature of the USA Hockey District Registrar and his/her designee. A team may not be allowed to play until all credentials have been checked.

RULE 3 – PLAYER ELIGIBILITY

- (a) No player will be allowed to play for a team unless his/her name appears on the USA Hockey player roster form signed by the USA Hockey District Registrar and his/her designee for that team for the 2009-2010 seasons.
- (b) No player will be allowed to play for more than one team.

RULE 4 – PLAYING RULES

- (a) The playing rules of the tournament will be such rules as laid out in the current USA Hockey Rule Book.
- (b) If changes in playing time are found necessary in the tournament, all managers will be advised well prior to commencement of the competition.
- (c) Each team will wear their respective uniform colors throughout the tournament. If possible, a home and away jersey should be provided.

RULE 5 – DURATION OF GAMES

- a) All games will be three 13 minute clock running periods.
- b) All games will be played with the Mercy Rule in effect.
- c) Penalties assessed during games will be followed as per the USA Hockey Rule Book.
- d) Overtime will apply <u>only</u> during championship games. After a three minute rest, the teams will immediately resume play, with the first goal determining the outcome of the game. Overtime will consist of one five (5) minute stop time period, with four players and a goalie. If the game is still tied at the end of overtime, the game will be determined by a five player shootout. If still tied, the shootout will continue with one additional player per team, until a winner is determined. NO player can shoot a second time until all other players on his team have taken a shot.

RULE 6 – TOURNAMENT DRAW

- a) 3 Teams will be selected for Mites, from all applications received. This is Recreational 'C' hockey and teams will be selected accordingly.
- b) Each team will be guaranteed four games.
- c) All teams will play each other in a round robin format, with a championship round and a consolation round.

RULE 7 – REGISTRATION CARDS OR CERTIFICATES

Please ensure that the tournament team roster information form is completed in its entirety and conforms to the USA Hockey player roster forms signed by the district registrar.

RULE 8 – REPORTING TIMES

Please have all teams present to the rink one hour prior to the start of their appointed game. All score sheets will be filled out and roster information will be required.

RULE 9 – LOCKER ROOM PROCEDURES

Team managers and coaches are responsible for maintaining a sportsmanlike and disciplined atmosphere with the players. Unsportsmanlike or undisciplined behavior will result in suspension of the player for the duration of the tournament.

RULE 10 – AWARDS

The team that is designated as champion will receive a trophy. All players participating in the tournament will be awarded participation medals.

RULE 11 – PROTESTS

- a) Protests must be filed by the team officials at the arena tournament office within one hour after the game, and must be submitted in writing.
- b) There will be a \$50.00 non-refundable fee for each protest filed.
- c) Any and all protests will be handled by our protest committee, and their decision will be final

RULE 12 – PROTECTIVE EQUIPMENT

All equipment requirements will be in accord with USA Hockey rules. All participants in all age groups must wear protective mouth guards at all times while on the ice!

RULE 13 – ON-ICE OFFICIALS

USA Hockey sanctioned officials only shall be used to officiate all games during the tournament.

RULE 14 – CONDUCT

- a) Any player or coach engaging in physical violence during a sanctioned event will be immediately expelled for the duration of the tournament. Physical violence will be interpreted by the on and off-ice officials. Their decision is final, and is not subject to protest.
- b) Only players, coaches, and on and off-ice officials are allowed in the bench area. Any spectator entering the bench area is subject to expulsion for the duration of the tournament at the discretion of the tournament officials. Repeated violations by single or multiple spectators of any one team will result in point deductions for that team, at the discretion of the tournament officials. The decision of the tournament officials is final and is not subject to protest.
