Dear Players and Parents:

A new season of Redhawk Hockey is about to begin! For your convenience we have attached the 2012-2013 registration packet which includes everything you need to know about the upcoming season and how to get registered.

The objective of the RHA Board for the 2012-13 season is to provide our Redhawk players and their families with the best possible hockey experience and value. Among the many benefits our club offers, we have narrowed it down to what we consider our top four:

- 1) Strong coaching and leadership.
- 2) Consistent and convenient ice times.
- 3) A continued tradition of excellence.
- 4) The best value in the area with no hidden costs.

Returning for their fourth season with the Redhawks is Jeff Nelson - Director of Hockey and Varsity Head Coach, and Harry Kohl – JV Head Coach, assisted by Mark Mullally and Jim Nelson. Not only is Jeff the all-time leading scorer for The University of Illinois at Chicago, he has won numerous coaching awards, including AHAI Coach of the Year. He has served as Director of Hockey for the Sabre Organization and was named Hockey Program Coordinator and Bantam AA Coach this year for the Sabres. Harry brings over 20 years of coaching experience, having coached at Marist, Sandburg, Chicago Mission and Chicago Fury hockey clubs. Both he and Jeff led the Varsity and JV teams last year on an unbelievable run in the playoffs with both teams joining the ranks of the “Elite Eight” in the State Playoffs.

In addition to our coaching staff, the Redhawk Hockey Club offers the convenience and close proximity to Seven Bridges Ice Arena for their home ice. Both Varsity and JV teams have their own locker rooms and a set, weekly practice schedule and weekend games that keep them on the ice approximately five days a week. We will also be offering weekly off-ice training beginning in October at Edwards Health & Fitness Center, located within walking distance of Naperville Central HS. The program, 8-10 sessions in length, focuses on the strength and flexibility of both the upper and lower portions of the body while increasing the aerobic capacity through interval training.

This year Naperville Central Redhawks will continue their tradition of excellence, participating in the West Division of the Illinois High School Hockey League, which consists of area high schools like Neuqua Valley, Waubonsie, Hinsdale Central and Naperville North. Players can expect to play 28 regular season games, plus additional scrimmage games, playoffs and tournament games, totaling approximately 40-50 games in the regular season. From the hockey experience they have gained with the Redhawks, some of our alumni have gone on to play Juniors, Division I and III club hockey and the USHL. Our most recent alumni, Shawn Nelson, the 2012 State of Illinois Player of the Year, signed with the East Coast Hockey League.

Finally, in recognizing the current demands on our families and the expense of the sport, we feel that we are offering the best value for the quality of hockey experience. Having looked at the pricing of local clubs we have found our fees to be substantially lower even in the face of rising expenses. And while many clubs collect slush funds during the course of the season, we offer a one-time cost that will cover all expenses, including tournaments and teambuilding events.

Coach Nelson will be running the **Ironman Conditioning Camp** Aug. 16, 18 & 20. The camp is comprised of three 90-minute sessions. This is a great way for players to get ready for tryouts.

**Tryouts** will be held Aug. 24 & 26. On Friday, August 24<sup>th</sup> it is **mandatory** that at least one parent accompany the skater to the tryout registration, as parental signatures are required. No skater will be allowed on the ice without the required signatures, proof of 2012-2013 USA Hockey Insurance, and full payment of tryout fees. Registration will begin at 3:00 p.m. in the lobby at Seven Bridges Ice Arena. There will be an optional, informational parent meeting in the lobby when the tryouts start. This meeting is designed for those who may have questions about tryouts or any questions in general regarding the RHA organization. The Friday tryout is closed to spectators, however, parents are invited to attend the scrimmage game that will be played on Sunday.

Parents and players of selected Varsity and Junior Varsity teams will be required to attend a **mandatory** meeting on Thursday, August 30<sup>th</sup> at 7:00 p.m. at Seven Bridges.

Please keep in mind that RHA is a **volunteer** organization. We need every family to help out in some way. Opportunities include fundraising events, managing a team, becoming a board member, pasta parties, team building events and many others. Please contact a board member to learn more about available opportunities to get involved!

2012-2013 Objectives & Tryout Procedures**

**RHA Objectives**

The Redhawks Hockey Association is a not-for-profit organization affiliated with USA Hockey and the Amateur Hockey Association of Illinois (AHAI). The Redhawks Hockey Association has the following primary objectives:

1. To provide and conduct ice hockey programs for full time students attending Naperville Central High School in Naperville Community Unit School District 203.
2. To promote, train, teach and develop the sport of organized ice hockey. To develop the physical, mental, emotional, and social well being of participants including development of the personal character traits of self-esteem, self-discipline, perseverance and sportsmanship.
3. To provide for a Varsity ice hockey team made up of the highest skilled players. Its primary purpose is to win games. Its secondary purpose is to further develop the skills of each Varsity player to their maximum potential.
4. To provide for a Junior Varsity ice hockey team. Its primary purpose is the development of skills and teaching of theory to each Junior Varsity player with the intention of preparing that player for tryouts to the Varsity team at a future date. Its secondary purpose is to win games.

Our goal is to allow for the greatest possible participation for those players willing to make a definite commitment to competitive hockey. All participants chosen to be a member of the Varsity or Junior Varsity team will be offered the opportunity to practice, and whenever possible, to participate in games relative to their demonstrated abilities. RHA provides a means for Varsity and Junior Varsity players to earn their school letters.

**Tryout Procedures**

Based upon the growing interest and past accomplishments of the Redhawks program we expect a strong and competitive tryout for both teams. Tryouts will be conducted as follows:

1. Two tryout sessions will be conducted. The first session will be closed. A scrimmage game will be played as part of the second tryout.
2. Players are expected to attend both tryout sessions. If a player must miss a tryout session, the player needs to contact Jeff Nelson (630-248-1938) prior to that session.
3. Players should be dressed and ready to skate 10 minutes prior to the start of the first tryout and should arrive 60 minutes prior to the start of the scrimmage game.
4. Team selection is determined solely by the RHA coaching staff. There are no positions guaranteed on any team.
5. Players can find out which team they are on by going to <http://www.redhawkhockey.com/> after the scrimmage game. The teams will be posted within 24 hours after the scrimmage game. The coaching staff will be available to discuss their decisions with the player. Team rosters do not need to be finalized until October 15th. Therefore, some team assignments can change between tryouts and October 15th.

Players will be permitted to play on two hockey teams during the 2012-13 season. However, players interested in doing this must contact the coach the first day of tryouts to discuss the commitment expected from the Redhawk organization. Players are expected to make all Redhawk practices. Absences will result in loss of playing time.

## Redhawks Hockey - Frequently Asked Questions

1. **Who is eligible to play for the Redhawks?** To play, you must be a full time student within the first eight semesters of high school at Naperville Central High School in Naperville Community School District 203.
2. **How many teams will there be?** This year the RHA is pleased to announce that once again we will field two teams, all of which will play in the West Division of the Illinois High School Hockey League. We will field one Varsity team and one JV team. These teams will be called Central Red and Central White.
3. **Who picks the teams?** The Coaches! The Board has absolutely nothing to do with team selections or the process.
4. **How many players make each team?** The Varsity is planning to select 17 players (15 skaters and 2 goalies). The JV is planning for a team of 14 players (12 skaters and 1-2 goalies). These numbers may vary depending upon the talent pool available at try-outs.
5. **What happens if a player does not make a team?** We work very hard with the Sabre Youth Hockey organization to assure that kids who do not make a Redhawks High School team have a place to skate.
6. **When and where are practices?** Seven Bridges is home ice for the Redhawks. This facility is conveniently located and offers each team its own permanent locker room! Practice times are:

Practice times may be swapped between Varsity and JV based on games and other considerations. Off-ice practice may continue past dates shown above at the coaches discretion.

7. **When are the games?** The West Division of the Illinois High School Hockey League offers games that are normally held in the late afternoon and evenings on Saturday and Sunday evenings.
8. **How many games and how long is the season?** The official season for the Illinois High School Hockey League West Division is a minimum of 28 regular-season games plus playoffs, totaling approx. 38 games for both Varsity and JV. Both teams will participate in a pre-season tournament, Thanksgiving and Christmas tournament. At the completion of the regular season league games, a league tournament will be held, followed by AHAI's Blackhawk Cup (also known as the State Tournament). The season runs from September to March.
9. **Can I play on 2 hockey teams?** The Redhawks will allow players on the Varsity and JV teams to play for another team. However, players interested in doing this must contact the coach the first day of tryouts to discuss the commitment expected from the Redhawks organization. Players are expected to make all Redhawks practices. Absences will result in loss of playing time.

- New varsity players will receive a third team jersey.
- Replacement jerseys, bags and warm-ups for all skaters may be purchased on request.
- While not provided, all players are required to have a red helmet, red pants or shell, and gloves matching the Redhawks color scheme for games and scrimmages,
- The \$300 tryout fee must be included with registration materials.
- The tryout fee must be paid in full before skater's first tryout/evaluation. Skaters registering after tryout/evaluation dates are not exempt from this fee.
- Payment options for remaining fees:
  - One time payment using check or cash due at first parent meeting.
  - If paying by installments, all four checks should be brought to the parent's meeting. Each check should be appropriately dated and made payable to the Redhawks Hockey Association.
- A \$25 fee will be assessed for returned checks.
- The \$300 tryout fee will be refunded if a skater/goalie is not offered a position.
- If a family has multiple skaters, a 5% reduction in fees for each skater in the family will be applied to the portion of the fee not associated with equipment.

Any refund due to injury will be pro-rated based on a 32 week season.

EXAMPLE:

First week of September thru end of March = 32 weeks

If fees are \$3000, 6 week refund would be  $\$3000 * 6/32 = \$562.50$

In order to be eligible for any type of refund:

- a) Player must miss minimum of 6 consecutive weeks of hockey due to injury
- b) Injury must be RHA hockey related (i.e. practice, game or authorized team activity)
- c) Refund amount will be pro-rated based on season fees, not including try-out fee, divided by # of weeks missed, maximum refund to be 50% of fees, unless deemed extraordinary circumstances\*\*
- d) Any player that missed 6 or more weeks cannot return to the ice (practice or game) unless they provide RHA with a doctor's release

# Redhawk Hockey Association Player Code of Conduct for the 2012-2013 Season



Due to several incidents involving fans, coaches, players, parents, and off-ice officials, the Redhawk Hockey Association Board feels it is necessary to remind everyone that we fully support the "Participant Code of Conduct" which has been set by USA Hockey.

1. No swearing or abusive language on the bench, in the rink or at any team function.
2. No lashing out at any official no matter what the call is. The coaching staff will handle all matters pertaining to officiating.
3. Anyone who receives a penalty will skate directly to the penalty box.
4. Fighting will not be tolerated. Fighting will result in an appearance before the Rules & Ethics Committee.
5. There will be no drinking, smoking, chewing of tobacco or use of illegal substance at any team function.
6. I will conduct myself in a befitting manner at all facilities (ice rink, hotel, restaurant, etc.) during all team functions.
7. I will arrive 60 minutes prior to each game and will be ready 10 minutes before practice
8. I will call my coach before I miss any practice or game
9. I will dress appropriately for arrival at all games (as directed by the coach)

Any player or team official who cannot abide by these rules or violates them will be subject to further disciplinary action including possible expulsion from Redhawks Hockey).

The NCHS Redhawks Hockey team also supports a Zero Tolerance policy towards Game Misconduct behavior by any of our players. The consequences for this behavior will be addressed as outlined below:

- 1) One game Misconduct (ejection from game) will result in appropriate AHAI ruling and suspension with an RHA Warning.
- 2) A second game Misconduct will result in appropriate AHAI ruling and suspension and a 3 game suspension by RHA.
- 3) A third game Misconduct will result in appropriate AHAI ruling and suspension and a 1 month full suspension by RHA.
- 4) A fourth game Misconduct will result in appropriate AHAI ruling and suspension and will be subject to team expulsion by RHA.

- 2. Uses obscene or vulgar language in a boisterous manner to anyone at any time.***
- 3. Visually displays any sign of dissatisfaction with an official's decision, including standing on the boards or standing in the bench doorway with the intent of inciting the officials, players, or spectators. Any time a coach persists in any of these actions (s)he shall be assessed a game misconduct penalty.***

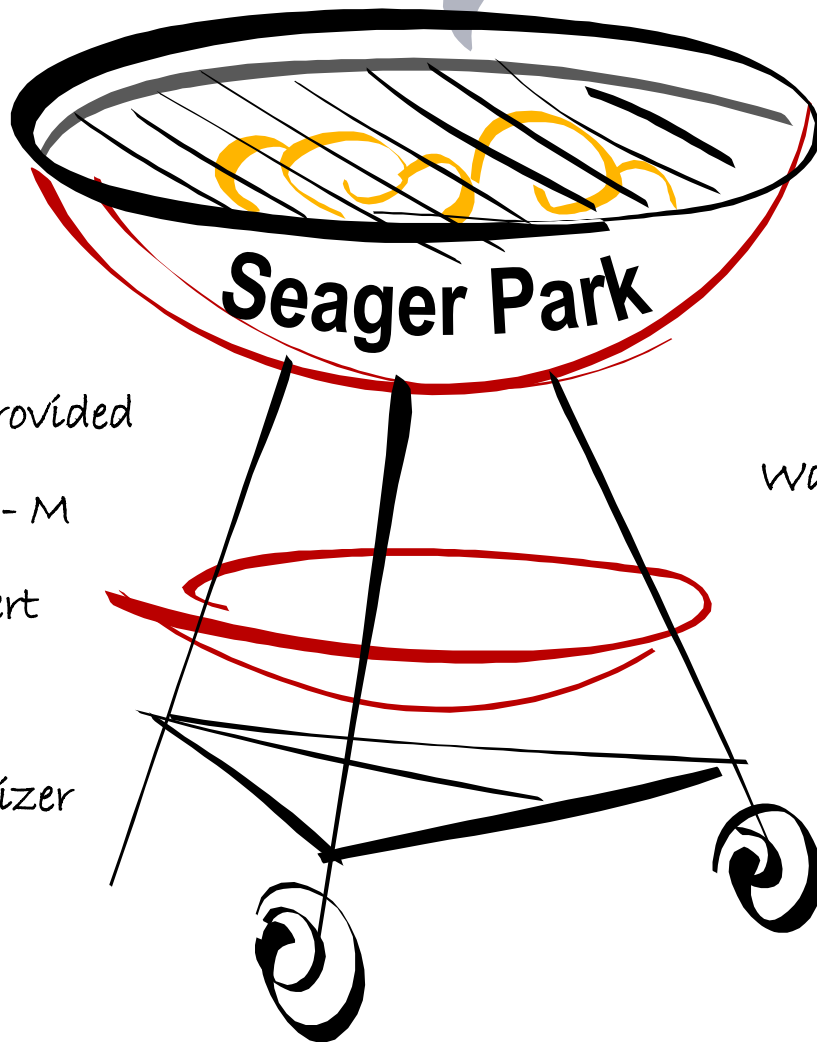
