

# Supplementary Regulations

## **Organized by the Golden Valley Historic Light Car Club**

1. The Golden Valley Historic Light Car Club will organize a Clubmen's Permit historic sporting trial at Sallywood Park, Horsley, Nailsworth, Glos GL6 0QA on Saturday 28<sup>th</sup> June 2014
2. The Meeting will be governed by the General regulations of the M.S.A. Led (incorporating the Provisions of Sporting code of the FIA). These SR's and any written instructions the organizing club may issue for the event.
3. M.S.A. Permit number 83515
4. The event is open to all fully elected members of the organizing club and members of the following invited clubs, BTRDA, NPTCC, 750 Motor Club, MCC, HSCC, VSCC and Stroud and District MC, MAC, Southsea MC, Kentish Border MC.
5. The event will be at Sallywood Park, Horsley, Nailsworth, Glos. GL6 1QA. Public Roads will not be used to link sections. There will be 6 sections on private land to be attempted at least 3 times. The entry will be split into groups starting at different hills to enable the programme to be completed.
6. Scutineering starts at 3.30pm. First test 4.30 pm.
7. Awards to be presented as follows  
Best overall performance of the day; Driver and Passenger. The Gordon Jackson Award  
Best Performance Historic Class Driver and Passenger  
Best Performance Post Historic Class Driver and Passenger  
A Special " Spirit of the day " Award to be presented at the Organisers discretion

The entry list opens on the publications of these SR's. **The entry fee is £25.00.** All entries must be completed on the official entry form and accompanied y the appropriate fee. **Cheques must be made payable to Golden Valley MCC** and sent to the Secretary of the Meeting. Entries will be accepted up to 24<sup>th</sup> June 2014. Entry fees will be refunded if the Secretary of the Meeting is notified 24hrs before hand.

16. All competing cars must be fitted with an effective silencer. A noise test may be carried out.
17. The use of motorcycles or quad bikes on the site is restricted to authorised persons only.
