- 1. A 30% discount on water/sewer/storm water charges for low income homeowners over 62, who reside in their Mountlake Terrace property.
- 2. No cost garbage service for residents of all ages who are eligible solely based on income.

To be eligible for either or both reductions your income must meet the guidelines below:

Exceptions may be made for those whose income exceeds the income guidelines, but due to circumstances, such as illness or temporary unemployment, are in need of temporary assistance.

13.05.375 Discount for low income senior citizens. Mountlake Terrace property owners over the age of 62 living on the property in a household with an aggregate income equal to or less than 140 percent of the established federal poverty level as now or hereinafter amended shall be eligible to qualify for a 30 percent discount on water, sewer and storm water charges. To qualify for the discount, applicants must complete an application form provided by the City and submit proof of income to the City Manager or designee. The discount will be effective with the next regular billing following approval of an application.

ALREADY EXEMPT? 2010/2011 EXEMPTIONS WILL STOP APRIL 30, 2011. YOU WILL NEED TO APPLY ANNUALLY.

<u>WISH TO APPLY?</u> Return this completed application **with proof of income**. Examples of proof: copy of most current tax return, social security benefits letter or end-of-year earnings statement.

**SOLID WASTE PICKUP PROBLEMS**: 425-481-1100 WMNW

To qualify for either discount applicants must prove occupancy by consumption showing on the individual water meter consistently during the discount period, and meet the income guidelines. Discount will be cancelled if no water is used during a two month billing period and customer will need to reapply once they are using water again. Approved discounts start the 1st of the month following approval.
