## Harbor Regional Center and Hop Hearings

Harbor Regional Center is an independent non-profit agency, like all Regional Centers, which has contracts with DDS to coordinate services for people with developmental disabilities, including those at Fairview and other DCs. Harbor Regional Center has announced that they will no longer participate in the Hop hearings for Fairview residents that would be heard in Orange County Superior Court. This decision was a major topic of concern at the July FFF meeting, as it may open questions about the placement of some Harbor RC residents at Fairview. FFF has been in close communication with DDS about this issue. Patricia Flannery, Deputy Director of Developmental Centers, shared this information with FFF:

*The Department of Developmental Services and Harbor Regional Center have had discussions regarding the concerns that were raised at the Fairview Family & Friends meeting. The Deputy Directors for the Community Services Division and the Developmental Centers Division and the Harbor Regional Center Director will be meeting to further the discussion which will include a review of the current status of each resident at Fairview currently served by Harbor RC. The Department will provide follow-up to the FFF after the discussions have been held.*

### FFF Welcomes E.D. Cheryl Bright and Fairview Staff

Cheryl Bright, newly appointed Executive Director of Fairview Developmental Center, was warmly welcomed by families attending the July 13 FFF meeting. Cheryl shared that her mother worked at a Pennsylvania developmental center, and would bring residents to their home to join in family activities. Her mother told her that the residents were entitled to a quality of life such as she had. This had a significant impact on Cheryl, who has had a full career in serving individuals with disabilities. Several members of Fairview staff also attended the meeting and spoke about their work with the residents, and gave information about the different programs and services that Fairview provides. ## FAIR HEARINGS

The Fair Hearing Process is part of the Lanterman Act that gives ALL Regional Center clients (including Fairview residents/conservators and community-based clients) a method to resolve disagreements with Fairview or with Regional Centers. The disagreement can be about IPP services, eligibility, or any decisions or actions that the client or their representative may consider “illegal, discriminatory, or not in their best interests.” This may include placement decisions by Regional Centers. There are 3 steps to the Fair Hearing Process:

1. **Voluntary Informal Meeting** is between the resident/conservator and the Fairview DC or Regional Center Director or representative. An attempt will be made at this meeting to resolve the disagreement. This first step may be declined by resident/ conservator, and a Mediation meeting requested.

2. **Mediation** is an informal meeting with a professional mediator from the Office of Administrative Hearings, a state agency for “fair and independent resolution of administrative matters.” However, the DC and Regional Center may decline to participate in mediation, or mediation may not resolve the problem. A Fair Hearing is then scheduled.

3. **Fair Hearings** are a formal review of the disagreement conducted by an Administrative Law Judge. If a resident/conservator wishes to bring a disagreement to a Fair Hearing, the process is started by filling out the Fair Hearing Request form. ## **Future of the Developmental Centers Task Force**

Some of the recommendations of this Task Force were included in the Governor's budget and signed into law, including developing New Models of Care for Challenging Behaviors; Enhanced Behavioral Support Homes; Community Crisis Homes; Acute Crisis Units at Sonoma and Fairview DCs; Community State Staff Program; and DC Resident Transition Planning. Several organizations (including FFF and CASHPCR) are part of a workgroup providing input on these proposals. Written comments from the public are also welcome. The full Task Force (with representation from Fairview and other DCs) was reconvened in July to "examine services for the developmentally disabled in the community. The Task Force will develop recommendations to strengthen the community system in the context of a growing and aging population, resource constraints, availability of community resources to meet the specialized needs of clients,." Although the focus of this Task Force is not directly on DC residents, its progress will have a direct effect on DC clients who are placed in the community. Representatives from Fairview and other Developmental Centers are on this Task Force.

## **Brent Snyder Fairview Resident Remembered by Family and Friends**

Brent Snyder came to Fairview about 16 years ago, where he blossomed and grew among friends, family and staff. He passed away suddenly in early July, when he was enjoying an outing on the Fairview grounds. Inspired by their love for Brent and pride in his accomplishments, his family has had a long and remarkable history of advocacy for people with developmental disabilities, across many states, many decades, and many programs. Brent's influence has improved services for countless individuals. The Snyder family has continued to share their commitment to individuals like Brent, by requesting donations in his honor be made to Fairview Families and Friends.
