<p>The Special Event applicant or president of designee of the sponsoring organization(s) (hereafter called “permittee”) agrees to reimburse the City of Oakland (hereafter called “City”) for all losses incurred by it in repairing or replacing damage to City Property proximately caused by the permittee, its officers, employees, agents, monitors, or any other persons or forming the special event, who were, or should have been, under the permittee’s control. Persons who merely attend or join in a special event are not considered by that reason alone to be “under the control” of the permittee.</p> <p>The permittee further agrees to defend without costs, indemnify, and hold harmless the City, its officers, agents, and employees from any liability to any persons, damages, losses, or injuries arising out of or alleged to arise out of the permitted special events, which was proximately caused by the actions of the permittee, its officers, employees, agents, including monitors, or any other persons attending or joining in the special event who were, or reasonably should have been under the control of the permittee.
