Eligibility

Everyone is welcome to join us! Must be able to ski or snowboard through gates (moderately difficult). Laser sailors must be able to sail and recover from a capsiz.

Rules

Skiing / Riding: Rules will be set by Bousquet Mountain Race staff. Separate liability form required (to be supplied at sign in).

Sailing: ISAF, US Sailing, ILCA, Sailing Instructions. Laser Class membership strongly encouraged but not required. Wetsuit or drysuit required - no exceptions. Lifevest must be on board, and worn unless waived by the RC.

Single Series

Division I – Ski or Snowboard only - CPYC members only \$20-

Division II – Ski or Snowboard AND Laser – all welcome \$25-

Division III - Ski or Snowboard AND (insert name of your fleet here) – all welcome \$20-

Directions

Bousquet: Bousquet Mountain is just off Route 7 at 101 Dan Fox Drive at the Lenox / Pittsfield, MA border.

CPYC: I-95 exit 17, turn right at end of ramp, 1 mile turn left onto Duck Pond Road, 1/4 mile turn left onto Harbor Road, 1/2 mile to wooden bridge, 3rd right, 1st left. **SPEED LIMIT 15** after bridge. **Trucks, Trailers & Car-top**

Lasers: DO NOT CROSS WOODEN BRIDGE! Instead, right on Canal Road, left at end, 2nd left, 1st right **CPYC shares Bluff Point in a residential neighborhood populated by many young children and pedestrians. Please be mindful of the 15 mph speed limit and stop signs on Saugatuck Island. The added minute or two will be safer, enhance your driving pleasure and do much to benefit our relations with local residents.**

I understand that serious accidents occasionally occur during skiing, snowboarding and sailboat racing, and that participants in skiing, snowboarding and sailboat racing occasionally sustain mortal or serious personal injuries and/or property damage as a consequence, and I knowingly assume all of the risks of skiing, snowboarding and sailboat racing. I agree that this waiver is binding on my heirs, representatives, successors and assigns.

I agree to abide by the Racing Rules of Sailing. I have read and understand Fundamental Rules 1 through 5. I understand that abusive language directed at another competitor or at a race official may result in penalties under rules 2 or 69.1(a).
