Students should have successfully completed the Basic Recruit Training course or have been exempted and possess sufficient experiences and background to meet the standard core of knowledge. Officers successfully completing Interview & Interrogation may be eligible for salary incentive or mandatory retraining requirement per Florida Statutes.
