**Design-Build Marine Service Center Water Filtration Shed Specifications** 

The basis for a Design-Build Water Filtration Shed must conform to the latest International Building Code, National Electrical Code, and Uniform Plumbing Code.

- Minimum 12"x6" reinforced footing at least 6" below grade with 6" stem wall extending 2' above finished floor elevation
- 6" concrete slab reinforced with 6x6 welded wire mesh with plastic vapor barrier beneath slab
- One floor drain with trap connected to adjacent drainage structure
- 6" minimum bottom chord on trusses
- 10' ceiling, minimum R30 Insulation
- 2x6 walls, R21 Insulation
- 4x12 roof pitch
- 5/8" sheetrock suitable for wet locations (green-board), fire taped only
- Metal sales T4, 24-gauge wall and roof panels or approved equal, over solid substrate, color to be selected by CBW. Include all necessary flashings and trim
- 36" man-door, <sup>1</sup>/<sub>2</sub> light, fiberglass, double bored, including locking knob and deadbolt
- 16'x 8' Overhead Door Co., Series 625 hand-operated rolling service door, or approved equal
- 200 amp single phase circuit panel with main breaker
- Surface mount EMT conduit for wiring
- Six (6) GFCI protected 120v duplex outlets interior and one exterior
- Two four-foot fluorescent, ceiling mount fixtures to be wired and installed, *(fixtures provided by CBW)*
- Two (2) Exterior lights to be wired and installed, one near each door, (fixtures provided by CBW)
- 10" exhaust fan
- 20Kw electric boiler
