DIRECTORS' EDUCATION & ACCREDITATION PROGRAMME

The Directors' Education and Accreditation Programme (DEAP) is an advanced director training course, aimed at preparing directors for the important role that they play in the governance of corporations. It is designed by the Institute of Chartered Secretaries and Administrators/Chartered Secretaries Canada (ICSA/CSC), in partnership with the law firm of Borden Ladner Gervais, and with contribution from AON Canada.

The programme is being offered in the region by Eastern Caribbean Securities Exchange Limited (ECSE), in continuation of its efforts to promote good corporate governance standards, in collaboration with the ICSA. The programme is also recognized and supported by the Eastern Caribbean Central Bank (ECCB), and the Caribbean Corporate Governance Forum (CCGF).

Registration to the programme is open to all directors and corporate secretaries of public and private companies as well as public sector corporations. CEOs, legal and accounting professionals and other corporate advisers as well as persons aspiring to directorships are also invited to participate.

The details of the programme are as follows:

Fee: EC\$5,000

Duration: 4½ days, with 1½ days devoted to each of the three broad areas, ie Governance, Financial Reporting & Disclosure and Strategy & Risk Management.
