<b>Facility:</b>	Silverlake Recreation Center, Kenton Lands Road, Erlanger, KY 41018 Please note the following: Coolers are not allowed in the facility. This privately owned facility offers a full service concession. Web site address – <a href="http://www.go2silverlake.com">www.go2silverlake.com</a> <b>Directions: Once in Kentucky, take I-275 to the Dixie Highway South Exit (#83). Go south, approximately one mile. Turn right on Kenton Lands Road (across from K-Mart). Go 1/2 mile and turn left into driveway for the facility.</b>
<b>Pool:</b>	This meet will only be run in one of the competition pools with 10-lanes. The timing system is Daktronics. The depth at the scoreboard end at 3.5 feet from the wall is 6'8"; at 16.5 feet from the wall is 6'8". The depth at the other end at 3.5 feet from the bulkhead s 6'8" and at 16.5' from the wall is 6'8". The pool has a moveable bulkhead therefore is currently not certified, however, if a national record is obtained, the Clippers will have the pool certified immediately following the meet.
<b>Age Groups:</b>	Ages 10 and under.
<b>Type of Meet:</b>	Timed Finals for all age groups. <b>The 9-10 year old events must be slower than the current National "BB" time standards.</b> A list of Cut Off times is enclosed and will be <u>strictly enforced</u> . This meet is designed to allow the younger swimmer to end the season on a fun and positive note.
<b>Scoring:</b>	This meet will be scored.
<b>Awards:</b>	Participants - All participants in the meet will receive a special award at the ceremony immediately following the last event. Individual - 1 <sup>st</sup> through 20 <sup>th</sup> places Relays -1 <sup>st</sup> through 10 <sup>th</sup> places
<b>Rules:</b>	Current USA Swimming rules will govern the conduct of the meet. All swimmers, coaches and officials must be registered USA Swimming members. Coaches and Officials must wear their USA Swimming card while on deck. Age on the first day of the meet will determine age group for the meet.
<b>Entry Fees:</b>	\$4.00 per individual event; \$7.00 per relay. \$2.00 per swimmer Ohio LSC charge <b>Entry Fees must accompany entries</b> or be received within four working days for the electronic (email) entries. Please make checks payable to Northern Kentucky Clippers Swimming, Inc. <b>Entries will not be accepted without payment.</b>
<b>Entry Limits &amp; requirements:</b>	<ul style="list-style-type: none"> <li>▪ This meet will be limited to approximately <b>200 swimmers</b>, including Clippers. No teams will be divided. No deck entries or changes will be accepted.</li> <li>▪ <b>Swimmers MUST be entered in 3 individual events to compete in this meet.</b></li> </ul>

	<ul style="list-style-type: none"> <li>▪ Swimmers may compete in five individual events, plus one relay.</li> <li>▪ Clippers do not have to meet the minimum # of swim requirement.</li> <li>▪ Deck entries will be accepted based upon availability of space. You must contact Rita Larkin before the meet at <a href="mailto:clippers.swimming@clipperswim.org">clippers.swimming@clipperswim.org</a> to see if we are taking deck entries, however no additional heats will be added. Deck entry fee will be \$5.00 per individual event, plus LSC charge if the swimmer was not already entered in the meet.</li> </ul>
<b>On deck registration</b>	We do not permit on deck USA Swimming registration of swimmers. All swimmers must have their USA membership prior to coming to the meet.
<b>Audio &amp; Video Restrictions</b>	Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.
<b>Swimmers attending without a coach</b>	Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
<b>Disability Swimmers</b>	Swimmers with disabilities are welcome to enter Ohio swimming meets. Coaches: 1. Enter the swimmers on Hy-Tel or the paper entry form; 2. Provide advance notice of any necessary accommodations; 3. List in the email with the entries (or on paper) the swimmer's name, entry times, strokes/distance, days/sessions, and how the swimmer prefers to be seeded. Swimmers with disability will be seeded with the same age grouping either the same distance race or a longer distance race (i.e. 500 free during the 100 free). Qualifying time standards at regular season meets are waived for swimmers with disability. For more info go to 'adapted' on the Ohio Swimming website.
<b>Entry Deadline:</b>	<b>Entries must be received by Friday, January 11, 2013.</b> Entries can be sent on a disc or via email to <a href="mailto:clippers.swimming@clipperswim.org">clippers.swimming@clipperswim.org</a> A paper copy along with the check and the USA Swimming Registration Form must be sent with the disc. <b>Or if entries sent by email, a copy of entries must be sent at the same time for verification.</b> Files should be loadable into Hytek Meet Manager using Commlink II.

<b>Warm-up Procedures:</b>	Warm-up procedures may, at the discretion of the host team, be modified based on number of swimmers in the meet and other safety and logistical concerns.  Ohio LSC Swimming Safety Guidelines and warm-up procedures will be in effect at this meet. a. We reserve the right to assign warm-up lanes. b. The coaches of the teams assigned to a lane shall determine the warm-up procedure for that lane. c. Except during supervised racing starts, swimmers must enter the pool feet first in a cautious manner with one hand in contact with the pool deck. d. The host team may choose to divide the warm-up into two sessions depending on the size of the meet. In this case, teams will be assigned "early" and "late" warm-up sessions on different days so that no team is advantaged over another. e. Coaches shall actively supervise their swimmers throughout the warm-up session.
<b>Officials:</b>	Any USA Swimming official who would like to officiate, please contact Clippers via e-mail or send a note along with meet entries. Please note your certification level, if an Ohio LSC official. We will rotate officials through all eligible positions.
<b>Recommended Hotel</b>	Courtyard by Marriott – Florence, KY Special rate of \$89 per night plus tax is offered. To book your rooms call Pat at 1-859-371-6464. Plus coaches will get their room at ½ price for 10 or more rooms picked up.
