REQUEST FOR BELL TIME CHANGE GUIDELINES

Schools considering a bell time change for the 2015-2016 SY must complete the below form in its entirety. It is important to note, the basic considerations schools should consider when changing your bell times. Schools are provided AM, PM and Midday transportation service based on school model, and programming. This service is provided according to district policy EEAA.

Transportation routes are tiered to service multiple schools with one bus. Planning takes into account the available resources available at each time increment, combined with all regulatory requirement, to determine if your bell time can be approved. Keep in mind that transportation department considers 173 schools when considering approvals.

Considerations and questions should be asked when

1. How will your change impact parent community and students?

2. Will your bell time change require additional district resources, i.e. funding?

3. If you want to extend your day, think about making adjustments in the AM vs. PM.

4. If you want to shorten your day, consider making the adjustment in the AM vs. PM.

5. If your bell time currently resides in the 3:00 PM - 3:55 PM and would like to made adjustments, considerations will be made to assess tradeoffs within each region with similar request.

6. If considering changing or adding an early release*, late in or ASA, schools are required to incur the incremental cost.

7.Bell time slots that have <u>no availability</u> to request modification are:

Any time between 7:30 AM & 7:45 AM

Any time between 3:15, 3:30, 3:45 & 4:00PM

8.Bell time slots that have availability to request modification are:

Any time between 2:30 PM-2:55 PM & 4:15 PM-4:45 PM

*The following days have <u>no availability</u> for you to consider a Early Release – Wednesday & Friday

Monday, Tuesday & Thursdays have capacity for schools to consider a early release.

Once form is submitted, Transportation (and identified departments) will review the request and provide information regarding:

- Financial impacts
- Personnel impacts
- Resource constraints
- Possible options to support the request.
- Approval or denial

Schools are encouraged to consult with transportation to seek probability of approval of bell time change prior to proceeding with CSC conversations and parent community buy in.
