David Bonar has headed the Public Advocate's office for Delaware since mid-2013.

The Public Advocate's office represents customers of regulated utilities in rate cases before the Public Service Commission, including those involving electricity, natural gas, water, waste water, basic cable

television and land line phones.

Mr. Bonar will describe his recent efforts as Public Advocate and answer your questions about rates and rate increases for various public utilities of interest

Legislative/Environmental - Bob Chin/Chuck Schonder

In the dozen years since I moved to Delaware, my electric bill had doubled and my water costs had quadrupled. The elderly tend to use more utilities because we are at home a lot. We like it cooler in the summer and warmer in the winter. We watch TV longer and flush more often. An AARP study found utilities account for a higher percentage of expenditures for the elderly than younger age groups, by as much as 10%. For us, the price must be fair.

In Delaware, the Pubic Service Commission oversees the costs of electricity, natural gas heating, water, waste water, telephones and cable TV. The Public Advocate is charged to "principally advocate on behalf of residential and small business consumers". In the case of electricity, the utility makes most of its' money from "costs" (building infrastructure and placing equipment in service) plus a profit margin. In essence, the more money they spend, the more money they make. The trick is for the PSC and the utilities to agree on what are the costs. A job for experts and lawyers.

The ordinary consumer is no match for the Delmarva, Tidewater and MediaComs of this world. The Public Advocate is supposed to even the odds and to speak for us. He cannot do this without hearing from you. David Bonar, our current PA, will speak at our March luncheon meeting. Here is your chance to learn, ask questions and express your opinions. An educated and expressive consumer is the best defense against the ever rising cost of utilities.
