You will find the awards application in this newsletter and on the website. Note that while we do have a volunteer to do the perpetual honor plaques, the Top Dog Award and the Club Achievement Trophy, (Gloria Newby) we do not have anyone to do the plaques and bars for titles earned in 2015. Remember that the honor plaques are for titles earned for UD,UDX, RAE, MX, MXJ, MACH, VST, TDX, CT and are plaques passed down from year to year. Top Dog is an award for top three scores in Novice, Open, and Utility. All are AKC only. The past recipients of the Club Achievement award are also in this issue and will be the first time we have awarded this since 2013.

I am having the applications mailed to me and will collect the information and send on to Gloria. If someone does step up to do the plaques and bars, I will send to that person as well. If that does not happen we'll just keep it on record and hope we can get someone at a later time. In any case, at the awards ceremony in February, we will announce the names and titles for all applicants. Please apply even if you do not wish to keep the honor plaques at your home or if you don't want the plaques and bars to keep as we would still like to acknowledge your accomplishments.

### **2015 WSOTC SANCTIONED OBEDIENCE MATCH REPORT – Sue Cox**

We had a very successful AKC Sanctioned Obedience Match on October 11<sup>th</sup>. So many exhibitors expressed their thanks for the opportunity to participate in such a match. Sanctioned Matches are rare anymore.

We ended up with 26 first entries and 16 additional class entries, netting an income of \$292.00. There were entries in every class offered. Expenses included ribbons (due to the minimum order requirements, we ended up with plenty for another match), morning refreshments and lunch for judges, ring stewards, and Club members staying for the meeting, gifts for judges Debbie Addicoat and Jim Franklin, paper goods, printing and miscellaneous items. I couldn't come up with enough rubber bands in my desk drawers so had to buy a bag of them! The net gain to the club is \$69.44. A financial report was submitted to the Treasurer and President. I'll send a copy to Laura in the event she wants to publish it in the *Canine Post*.

Winner of Highest Scoring Dog in Match from the Regular Classes was Doreen Pezzella with her Novice B Papillon, Gizmo, scoring a 189. There were some higher scores in other Regular classes, but dogs titled in those classes are not eligible for prize competition.

Report of the President: Thank you to Sue Cox for organizing the sanction match. Thank you to Laurie Weaver for the use of her building for the Laura Romanik seminar and for the sanction match today. Thank you to Betty Winthers, Ingrida Robinson and Janice Bergman for their work on the Audit/Budget Committee.

Report of the Secretary: see October Board minutes in the Canine Post.

Report of the Treasurer: All the financial reports and information are in the members-only section of the Club's website. Financial report for year 2014-2015 shows the Club is in the black.

Report of the Board: Due to time constraints the Board will return to Standing Rule revisions in November. For the AKC Lifetime Achievement Awards, the Board voted for Patti Strand for Conformation, John Cox for Companion Events and John Russell for Performance. The Board approved the 2015-2016 Club budget which now will require membership approval. Board approved making a donation of \$1500 for a dog-related charity (will need to appoint a donations committee in November to recommend a charity). Board authorized Ingrida Robinson, current treasurer, and Wanda Diemert, past treasurer, to move the Club's accounts from Bank of America to Boeing Employees Credit Union. Board approved the December 2015 TDX trial budget.

Announcements/Committee Reports:

Agility – no update

Awards – Wanda Diemert and Nancy Light will be revising the awards application (more information to be in the next issue of Canine Post) to include the top three scores in Novice, Open and Utility for the Top Dog Awards. Thank you to Gloria Newby for volunteering to co-chair the Awardcommittee. Club will also be engraving the Honor Plaques for titles earned for UD, UDX, OTCH, MX, MXJ, MACH, TDX, CT and RAE.

Audit/Budget Committee – recommended budget is presented under New Business. The Club's books were audited and found to be in good order.

Hearts and Flowers – please contact Gloria Newby if you know someone to whom a card should be sent.

Match/Sanctioned Match – Sue Cox set the Sanction Match date for October 11 at Canine College. Registration forms are on the website. Match went well today. Thank you to our judges, Jim Franklin and Debbie Addicoat.

Newsletter – the October Canine Post should be going out via email today. The Board has recommended that the Club no longer print paper copies and mail them out to members who have email addresses. This will be a cost savings. All issues will now be emailed except for the three members who do not have email addresses. These three members will continue being sent paper copies that a club member has volunteered to print and mail at the Club's expense, rather than printing at a 3rd party vendor. The Board has not received any negative comments to this recommendation, so will implement with the next issue.

Obedience seminar – Nancy Light reported the Laura Romanik seminar was held September 26-27. Great success. Attendees gave positive feedback. The event brought about \$1500 into Club's treasury. Some attendees asked that she be brought back again, but Nancy Light suggested that the Club might wish to find another presenter for next year. ## **Obedience Rally Agility Tracking Versatility**

Plaques will to be award annually, at the February membership meeting to members who have received American Kennel Club (AKC) title(s) on their dog(s) *during the preceding calendar year*. The following rules apply:

1. Any or all titles must be received while a member of WSOTC.
2. Dogs must be owned or co-owned and handled by the WSOTC member.
3. The member must have acquired 4 points by attending membership meetings, assisting at trials/events, service to the club, the year the titles were earned.  
*Plaques will be available at cost to those members not meeting requirements, see cost below.*
4. One plaque per dog will be awarded with the first title plate earned for the first AKC title earned in Agility, Obedience, Rally or Tracking. Title plates only will be awarded in subsequent years for AKC titles.
5. Completed plaque applications must be submitted to the Club Award Chairman by January 12, 2016
6. Titles in **boldface** are those that are eligible for engraving on the perpetual honor plaques.
