"STEP 9: MADE DIRECT AMENDS TO SUCH PEOPLE WHEREVER POSSIBLE, EXCEPT WHEN TO DO SO WOULD INJURE THEM OR OTHERS."

The ninth step begins with a list – the basis for our amends supplied by step eight. I've made a lot of lists in sobriety, but not nearly as many as I made drunk. Best intentions were a thin defense against an ever-worsening reality, and lists bloomed like moss on a rock, unthreatened by the prospect of action. There were books to read, vitamins to take, relatives to call on their birthdays, exes not to call after 6 or more beers. There were penny-pinching guidelines, and moral codes I couldn't remember scribbling – appearing the next morning like divine inspiration, except with tricky words like "adultery" misspelled.

By contrast, the stuff we put on paper in AA tends to have real relevance to life as we live it. That's why the eighth step maintains its capacity to frighten: Nine lurks just behind, ready to hold you to your word – and your word is "willing." That's when slippery yearning for alternatives sets in: Are amends really necessary, if we promise to conduct ourselves differently? We've seen the error of our ways, now can't we forget them? That valley between intention and action beckons, asking us to make it our unhappy home.

When "any length" begins to seem too far in the pursuit of sobriety, fear and selfishness, those usual suspects, have made their insidious, predictable, return. It's no mistake that the ninth step invites their resistance: They have the most to lose if we persevere here. Our fourth and fifth steps amount to a moral history, in which fear and self-centeredness ruled tyrannically. In the ninth step, we find a fitting antidote: In total concern for others, we confront the conversations we fear most.

The ninth step entails more than acknowledging the victims of the way we lived, when we snapped like wounded animals at anyone kind enough to draw near. That much constitutes human decency, but as we've learned thus far, we need more than mere human power to proceed. The ninth step means recognizing that nothing less than selfless courage will set right a record of selfish fear. It means having faith that as we address the past, a spiritual source will supply the power we lack.

As I wrote out my eighth step, a part of me suspected it would go the way of my best laid drunken plans: nowhere at all, stymied by my own inability to change, whatever my desire. Surveying the list of those I'd harmed, I felt I lacked the constitution to continue on the path my list set me on, towards amends.

That turned out to be true, in its way. We Agnostics reminds us, "We could wish to be moral, we could wish to be philosophically comforted, in fact, we could wish these things with all our might, but the needed power wasn't there." But that void is where spiritual help arrives. I've made many amends in my sobriety, and many still remain to be made. But without the presence of a power greater than my own, that eighth step would still just be names on a page, nothing more than empty intention. If step nine seems to require strength we don't possess, it has that in common with our sobriety as whole. In these cases, yours and mine, God makes the difference.
